## 1. APPROVAL OF MINUTES

- Motion to Approve (Commissioner Davis) Second (Commissioner Rothrock) Approved-8-0

#### 2. CITIZEN COMMUNICATION: GENERAL

- Dale Bulla
  - o Expressed concern with the \$2 million decrease in Austin Energy solar budget
- Ryan Rosshert
  - Encouraged to come by 350 Austin; calls for 0% carbon emissions by 2030, closing the Fayette Coal Plant and notes the importance of the Austin Energy Resource, Generation, and Climate Protection Plan

#### 3. NEW BUSINESS

- a) Low Carbon Concrete Tom Ennis, Watershed Protection Department (Discussion and/or possible action)
  - Discussed opportunity to reduce emissions using low-carbon concrete in city construction projects
  - Concrete use does not have to be approved by Austin City Council, City Engineer looking to pilot use and explore using this across all municipal projects
  - Discussion on timing, cost, and green building credit potential, flexibility of use and potential improvements in the manufacturing process
  - Commissioner Coyne makes motion Commissioner White seconds to pass JSC recommendation supporting utilization of low carbon concrete, pending city engineer's confirmation of feasibility, Motion approved 10-0
- b) Lessons Learned Report on the 2015 Community Climate Plan Zach Baumer, Office of Sustainability (Discussion and/or possible action)
  - Reviewed summary of strategy implementation across the three climate plan sections
  - Emissions have reduced slightly since the adoption of the plan, would be 40% from baseline by 2030 based on current projections
  - Transportation will be bigger challenge as generation emissions reduce
  - Evaluated pros and cons of strategies; hoping to focus on more actionable strategies with quantifiable targets during upcoming revision
  - Reviewed carbon impact statement used to evaluate planned unit development
    - Discussion on how to improve enforcement of carbon impact across developments and potentially changing point structure to match impact of strategy
- c) Presentation on the Plan for the Climate Plan Revision—Zach Baumer, Office of Sustainability (Discussion and/or possible action)
  - Overview of estimated timeline, climate plan sections and community engagement strategies
  - Equity will be a key part of revision process
  - Discussion on importance of accountability and leadership buy-in within implementation process
