APPROVAL OF MINUTES

- 1. Approve the minutes of the March 27, 2019 Austin Energy Utility Oversight Committee meetings.**

There were two speakers:

- Danny Fetonte said that the Fayette coal plant produces money and coal ash which affects the surrounding communities and its children. He said Austin should help close down the Fayette plant in addition to giving up its share of ownership.

- Gilbert Starkey stated 350 Austin wants to work with Austin and LCRA to shut down Fayette as soon as possible.
