



**AUSTIN ENERGY UTILITY OVERSIGHT COMMITTEE

OCTOBER 23, 2019**

CITIZEN COMMUNICATION: GENERAL

There were two speakers:

- Al D’Andrea stated that Austin Energy’s energy efficiency program does valuable work in the community. He said he supports the approval of rebate funds for the entire year since it can be a struggle to move projects forward if property owners hear projects may take an extra two months.
- Paul Robbins stated the price of natural gas is volatile, and generation will remain dependent on natural gas. He said Austin needs to invest in dispatchable renewable energy and join with other utilities to look into building a concentrated solar facility.
