### **A. CALL TO ORDER**

Chair Lewis called the meeting to order at 6:03 p.m.

### **B. APPROVAL OF MINUTES**

1. Approve the minutes of the Parks and Recreation Board meeting of May 28, 2019.

Board Member Morgan made a motion to approve the minutes. Vice Chair Farasat seconded the motion. The motion carried on a vote of 8-0 with Board Member Luca off the dais, and Board Members Taylor and Cottam Sajbel absent.

#### **3. Select members to serve as chair of the Contracts and Concessions Committee and chair of the Land, Facilities, and Programs Committee.**

Chair Lewis nominated Board Member Morgan to serve as chair of the Land, Facilities, and Programs Committee. Board Member Morgan accepted the nomination. Vice Chair Farasat seconded the nomination. The motion passed on a vote of 8-0, with Board Member Luca off the dais, and Board Members Taylor and Cottam Sajbel absent.

Chair Lewis made a motion to postpone the nomination of the chair to the Contracts and Concessions Committee until the next regular meeting of the Board. Board Member Mason-Murphy seconded the motion. The motion passed on a vote of 8-0, with Board Member Luca off the dais, and Board Members Taylor and Cottam Sajbel absent.
