WHEREAS, on December 13, 1979, City Council also approved the Articles of Incorporation (Articles) and authorized the incorporators of the Corporation to file the Articles with the Office of the Secretary of State in the manner provided by law; and

WHEREAS, on September 16, 1993, City Council approved Articles of Amendment for the AHFC and authorized the filing of the Articles of Amendment with the Office of the Secretary of State in the manner provided by law; and



Attachment 1

The City Council of the City of Austin, Texas, on December 5, 2019, at a City Council meeting duly called with a quorum present, adopted these Articles of Amendment for the Austin Housing Finance Corporation on a majority vote of the City Council Members pursuant to the Texas Housing Finance Corporation Act.

1. The Articles of Incorporation of the Austin Housing Finance Corporation are amended by adding a new Article Fourteen and Article Fifteen:

"ARTICLE FOURTEEN

OFFICERS

The board of directors shall elect or appoint the officers of the Corporation in the manner and for the terms provided in the bylaws."

"ARTICLE FIFTEEN

BYLAWS

The board of directors shall make bylaws for the Corporation that are consistent with the Articles of Incorporation and the Texas Housing Finance Corporation Act for the administration and regulation of the Corporation's affairs."


2. The Articles of Incorporation of the Austin Housing Finance Corporation are altered by amending:

ARTICLE EIGHT


Article Eight is altered by adding the following to the end of the Article:

"After the initial board of directors, the board of directors shall be the duly elected City Council members of the City. Each director serves for a term equal to their term as a City Council member or until their successor director is duly elected and qualified. Any vacancy shall be filled in accordance with the City's Charter."

I have verified and executed these Articles of Amendment effective December 5, 2019.




