#### Posting Language

Authorize negotiation and execution of an amendment to the professional services agreement with McKinney Architects Inc. D/B/A McKinney York Architects, for additional architectural services for the Montopolis Recreation and Community Center, in the amount of \$45,037, for a total contract amount not to exceed \$1,333,037.

[Note: This amendment will be awarded in compliance with City Code Chapter 2-9B (Minority Owned and Women Owned Business Enterprise Procurement Program). Current participation to date is 41.09% MBE and 10.03% WBE.]

#### Additional Backup Information:

In 2012, Austin voters approved a new Montopolis Recreation and Community Center as part of Propositions #14 for Parks and Recreation Department and #17 for the Health and Human Services Department (now Austin Public Health). The Montopolis community is a multicultural and bilingual community in East Austin. The

Montopolis Recreation and Community Center has been an integral part of the community for more than 40 years. The purpose of this project is to provide a newly improved recreation and community center to the residents of the Montopolis neighborhood and citizens of Austin, while incorporating the historical and cultural values into the new building's design.

The project is currently under construction. This request is for additional design services for mechanical, electrical and plumbing services for changes required to a hydraulic elevator and changes to accommodate an electric washer and dryer. Also included in this request is remaining construction phase and post-construction services including necessary permit revisions, project close-out and warranty phase services. This request covers additional design, and construction and post-construction phase services.

This amendment has been approved by the City's Change Control Committee. The Change Control Committee was established to comply with Council Resolution No. 20120126-048, which required the establishment of consistent criteria and process to evaluate contractual changes for all contracts administered by the Capital Contracting Office.
