

AUSTIN CITY COUNCIL MINUTES

SPECIAL CALLED MEETING WEDNESDAY, FEBRUARY 5, 2020

The City Council of Austin, Texas convened in a Special Called Meeting on Wednesday, February 5, 2020, City Hall at 301 W. Second Street, Austin, Texas.

Mayor Adler called the Council Meeting to order at 9:12 a.m. Mayor Pro Tem Garza was absent.

COUNCIL DISCUSSION

1. Land Development Code revision discussion

Topics covered were: Drainage and water Quality; Parks; Trees and Site Plan/Process.

Presentation was made by Brent Lloyd, Development Officer, Development Services Department; Matt Hollon, Program Manager, Watershed Protection Department, Donna Galati, Program Manager, Development Services Department, Annick Beaudet, Assistant Director, Transportation Department and Scott Grantham, Planner, Parks and Recreation Department.

Direction was given to staff to ensure that the departments responsible for enforcement have the necessary resources for enforcement of the requirements in the new land development code; to provide more details on modeling done in areas prone to localized flooding;
