Posting Language

Authorize award of a multi-term contract with Lauren Concrete, Inc., to provide ready-mix concrete, for up to five years for a total contract amount not to exceed \$1,735,000.

(Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established).

Fiscal Note

Funding in the amount of \$126,511 is available in the Fiscal Year 2019-2020 Operating Budget of Public Works. Funding in the amount of \$42,170 is available in the Fiscal Year 2019-2020 Operating Budget of the Watershed Protection Department. Funding for the remaining contract term is contingent upon available funding in future budgets.

Purchasing Language:

The Purchasing Office issued an Invitation for Bids (IFB) 6200 BJT1009REBID for these goods. The solicitation issued on November 25, 2019 and it closed on December 19, 2019. The recommended contractor submitted the only responsive offer. Additional Backup Information:

The contract is for the supply of ready-mix concrete to be used by the Watershed Protection Department and the Street and Bridge Division of Public Works on an as-needed basis. The Watershed Protection Department will use the concrete mix for storm drain maintenance and construction activities, gutter construction, and driveway construction. The Street and Bridge Division will use the ready-mix concrete for concrete pavement

repairs, concrete utility cut repairs, sidewalk construction, Americans with Disabilities Act ramp construction requirements, curb and gutter construction, driveway construction and bus stop pad construction by City crews.

This contract will replace a contract which expired on January 17, 2020. The requested authorization amounts for the contract were determined using departmental estimates and historical spending. The recommended contractor is the current provider for these goods.
