Minutes:

1. Call to Order

Mary Arnold called the meeting to order at 4:34 p.m.

2. Item 1 (Citizen Communication)

- a. Holly Reed (President of the West Austin Neighborhood Group): Ms. Reed stated that the West Austin Neighborhood Group (WANG) is in the process of taking a public position in support of the Muny Conservancy's plan to preserve Muny as an 18-hole golf course with its historical integrity intact. She has recently been told by Richard Suttle (UT representative) that UT has no set plans for any portions of the Brackenridge Tract. Ms. Reed discussed the possibility of WANG not opposing UT development on the married/graduate housing tracts in exchange for Muny retaining its historical integrity. The non-opposition position from WANG assumes a density in line with the terms set forth in the 1989 Brackenridge Development Agreement. Ms. Reed will be representing WANG at a Muny stakeholders meeting tomorrow morning.
- b. <u>Bob Ozer (Save Muny)</u>: Mr. Ozer sees multiple partnership opportunities for Muny based upon the cultural and educational value tied to the historic site. He recently met with a representative of UT's

Briscoe Center to discuss Muny's civil rights history and the aforementioned opportunities. He is also reaching out to philanthropic organizations. Mr. Ozer believes the SHMD's current funding mechanism is insufficient in allowing for meaningful negotiations with UT and should be revamped by the Texas Legislature. Mr. Ozer suggested that there may be advantages for keeping Muny as UT-owned and that UT be paid for the act of applying a conservation or historical easement to the title.

3. Item 2 (Approval of 11/20/19 Meeting Minutes)

Brian Greig moved that the November 20, 2019 draft minutes be adopted. Ken Tiemann seconded the motion. **The motion passed 3** – **0**.
