AN ORDINANCE ACCEPTING GRANT FUNDS FROM THE ST. DAVID'S FOUNDATION; AND AMENDING THE FISCAL YEAR 2019-2020 OPERATING BUDGET SPECIAL REVENUE FUND (ORDINANCE NO. 20190910-001) FOR THE PARKS AND RECREATION DEPARTMENT AND THE AUSTIN TRANSPORTATION DEPARTMENT TO ACCEPT AND APPROPRIATE GRANT FUNDS FOR THE WALNUT CREEK METROPOLITAN PARK PLAYSCAPE REPLACEMENT PROJECT AND THE AIRPORT BLVD – MLK JR. BLVD TO U.S. 183 PROJECT; AND AMENDING THE PARKS AND RECREATION DEPARTMENT'S CAPITAL BUDGET AND THE AUSTIN TRANSPORTATION DEPARTMENT'S CAPITAL BUDGET (ORDINANCE NO. 20190910-001) TO TRANSFER IN AND APPROPRIATE GRANT FUNDS FOR THE WALNUT CREEK METROPOLITAN PARK PLAYSCAPE REPLACEMENT PROJECT AND THE AIRPORT BLVD – MLK JR. BLVD TO U.S. 183 PROJECT

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1.** Council authorizes the acceptance of \$209,126 in grant funds from the St. David's Foundation for the Walnut Creek Metropolitan Park Playscape Replacement Project and for consulting and community engagement services for a green space project in the City's right-of-way related to the City's Airport Blvd MLK Jr. Blvd to U.S. 183 project.
- **PART 2.** Council amends the Fiscal Year 2019-2020 Operating Budget Special Revenue Fund (Ordinance No. 20190910-001) in the amount of \$199,122 from the St. David's Foundation for the Parks and Recreation Department, of which \$19,820 will be used to activate park space for the Walnut Creek Metropolitan Park Playscape Replacement Project.
- PART 3. Council amends the Fiscal Year Operating Budget Special Revenue Fund (Ordinance No. 20190910-001) in the amount of \$10,004 for the Austin Transportation Department for consulting and community engagement services for a green space project in the City's right-of-way related to the Airport Blvd MLK Jr. Blvd to U.S. 183 project.
- **PART 4**. Council amends the Fiscal Year 2019-2020 Capital Budget of the Parks and Recreation Department (Ordinance No. 20190910-001) to transfer in and appropriate \$189,306 from the Fiscal Year 2019-2020 Operating Budget Special Revenue Fund for the Walnut Creek Metropolitan Park Playscape Replacement Project.

PART 5. Council amends the Fiscal Year 2019-2020 Capital Budget of the Austin Transportation Department (Ordinance No. 20190910-001) to transfer in and appropriate \$10,004 from the Fiscal Year 2019-2020 Operating Budget Special Revenue fund for consulting and community engagement services for a green space project in the City's right-of-way related to the Airport Blvd – MLK Jr. Blvd to U.S. 183 project.
