Purpose: Inform the decisions of Panels 1 and 2 and provide support and infrastructure across City departments during the economic recovery phase.



Economic Recovery Framework Next Steps

- Convene Economic Recovery Experts Panel & Directors Economic Recovery Panel.
- Finalize membership for remaining panels.
- Continue to provide immediate economic resources to businesses and individuals.
- Collaborate with the Intergovernmental Relations Office to ensure Austinites maximize economic opportunities from federal sources, such as the Coronavirus Aid, Relief, and Economic Security (CARES) Act.
- Identify municipal programs that can be repurposed for short-term and long-term assistance.



Economic Development Dept. Update

- Austin Business and Non-Profit Recovery Loan
 - EDD is waiting for approval from Housing and Urban Development (HUD) before accepting loan applications.
 - EDD has already created website (coaloans.com), trained staff and partnered with other City departments (CTM, Austin 3-1-1) to ensure program is ready for launch once HUD grants approval.
 - Applicants who meet the eligibility criteria can to apply for up to \$35,000 loan with low interest-rates, repayable in 12 months.
 - Applicants must also apply for the federal Economic Injury and Disaster Loan (managed by the U.S. Small Business Administration).



Economic Development Dept. Update

• EDD case managers can help explain the loan programs created through the federal CARES Act.

Economic Injury Disaster Loans

Offers small businesses access to low interest loans up to \$2 million to pay for operating expenses. Small businesses can receive a \$10,000 advance that does not require repayment—regardless of whether the loan application is approved.

Paycheck Protection Program

Offers loans of up to \$10 million for payroll, mortgage, rent, utilities, etc. The federal government will forgive payments if the funds are used for payroll costs, interest on mortgages, rent, and utilities.



Economic Development Dept. Update

- EDD administrative modifications in response to COVID-19:
 - **Created online resource databases** for small for small businesses and nonprofits (austintexas.gov/covid19 and austintexas.gov/small-business-resources).
 - Modified Creative Space Assistance Program to release up to \$1 million in funds earlier.
 - Provided free online business coaching through our Small Business Program.
 - Completed more than 200 coaching sessions since March.
 - Contributing to Travis County COVID-19 Economic Impact Dashboard, which will include metrics on workforce, business and economic impacts.



Housing & Community Development Update

- NHCD actions in response to COVID-19:
 - Created online resource database for individuals seeking housing and financial assistance in response to COVID-19. (austintexas.gov/covid19 and austintexas.gov/housing-resources)
 - **Developing informational support for renters** especially those who have difficulty paying rent and/or understanding local, county, and federal eviction protections.
 - **Partnering with community agencies** to deploy funding to assist individuals impacted by COVID-19.



Exchanging Ideas with Other Municipalities

- EDD staff are researching programs implemented by other municipalities.
- Information from discussions and research are placed into a program inventory.
- Each local context is different, but exchanging best practices enhances our ability to support those impacted by COVID-19.

Washington DC	Small Business Recovery Microgrants	Grant	Multi	Grants to small, local businesses, independent contractors, self-employed individuals, and nonprofits to meet their short-term financial needs
Portland, OR	Jade District-Oldtown COVID-19 Small Business Response Fund	Grant	Small Business	Up to \$190,000 for businesses within Jade District experiencing a dramatic downturn in business due to fear and xenophobia
Hillsboro, OR	Hillsboro Small Business Emergency Relief Program	Grant	Small Business	\$5,000 grant to offset losses
