# Posting Language

Approve an ordinance amending the Fiscal Year 2019-2020 Austin Resource Recovery Department Operating and Capital Budgets (Ordinance No. 20190910-001) related to the expansion of community cleanup efforts.

#### Fiscal Note

Funding in the amount of \$3,269,300 is available in the Fiscal Year 2019 2020 Austin Resource Recovery Department's Operating and Capital Budgets. A fiscal note is attached.

#### Prior Council Action:

On September 10, 2019, Council approved Ordinance No. 20190910-001 adopting the Fiscal Year 2019-2020 Austin Resource Recovery Department Operating Budget. This adoption included a budget amendment sponsored by Councilmember Paige Ellis to maintain the Clean Community Fee at its current Fiscal Year 2018 -19 level rather than decreasing the fee as had been proposed by the department.

#### Council Committee, Boards and Commission Action:

On September 4, 2019, the Zero Waste Advisory Commission voted unanimously to recommend the department's proposed FY2019-2020 Budget.

#### Additional Backup Information:

The amendment to the Operating Budget increases revenue and expenditures by \$3,269,300 and adds 12 fulltime equivalent positions. \$1,717,815 of the total funding will be transferred to the Austin Resource Recovery Capital Budget for the purchase of related vehicles and equipment for this increased work.

The Clean Community Fee (CCF) supports Litter Control in designated public areas, Street Sweeping, Dead Animal Collection, Landfill Closure and post-closure requirements, Business Outreach, Zero Waste Strategic Design and Development, Brownfields Remediation, and recycling and non-commercial hazardous waste disposal at the Recycling & Reuse Drop-Off Center (RRDOC).

Council's adopted Fiscal Year 2019-2020 Budget (Ordinance No. 20190910-001) maintained the CCF at its 2018-2019 level and directed staff to use the funds for increased cleanup within the City.
