



**AUSTIN CITY COUNCIL  
MINUTES**

**WORK SESSION MEETING  
TUESDAY, APRIL 7, 2020**

The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, April 7, 2020, via Videoconference.

Mayor Adler called the Council Meeting to order at 9:10 a.m.

**BRIEFING**

- B1. Briefing on matters relating to COVID-19 including prospective budget impacts.

Ed Van Eenoo, Deputy Chief Financial Officer and Veronica Briseno, Director, Economic Development Department.

**BRIEFING CONTINUED**

- B1. Briefing on matters relating to COVID-19 including prospective budget impacts.  
Discussion continued.

Direction was given to staff to provide additional information on how the higher education institutions are assisting possibly with use of college dorms; information on where donations can be made; information on the number of positive cases within the area nursing homes; provide contact information for the Nursing Home taskforce and City Committees that have been created; information on the types of communication occurring in the West Campus area; point of contact for construction issues and compliance; analyze options for adjusting the budget adoption schedule; recommendations on job training and digital access will be needed as the City recovers; information on updated projected general fund revenues; the timeline and options for expediting the process for releasing rental assistance funds; to distribute information regarding the Mayor's Order and the Council Ordinance relating to

**evictions; plans to augment our human and capital infrastructure that would ensure the City and our residents are more resilient.**

### **COUNCIL DISCUSSION**

9. Approve an ordinance adopting the Third Amendment to the First Amended and Restated Agreement Concerning the Creation and Operation of Senna Hills Municipal Utility District to change uses and impose certain conditions. This action concerns land located within the Barton Springs Zone.
30. Approve a resolution related to magistrations services provided by Austin Municipal Court judges, and reforms to end wealth-based detention and improve equity in the Travis County justice system. Approve an ordinance amending the Fiscal Year 2019-2020 General Fund Emergency Reserve Fund (Ordinance 20190910-001) to appropriate an amount not to exceed \$15,000,000 for the Relief in a State of Emergency (RISE) Fund to support COVID-19 emergency relief to supplement but not supplant Federal and State funding, and declaring an emergency. Council Sponsors: Council Member Gregorio Casar, Mayor Pro Tem Delia Garza, Mayor Steve Adler, Council Member Kathie Tovo, Council Member Sabino 'Pio' Renteria.
83. Conduct a public hearing and approve an ordinance adopting a moratorium on city utility disconnections, waiving city utility late fees, extending the deadline for commercial and multifamily energy audit and benchmark reporting, reducing certain city electric and water rates, expanding eligibility for the city utilities' customer assistance program to include individuals experiencing financial hardship due to the COVID-19 pandemic, amending the fiscal year 2019-2020 budgets of Austin Water and Austin Energy to appropriate up to \$10,000,000 for the utilities' Plus-One payment assistance programs, and declaring an emergency.
