The first 10 speakers signed up prior to the meeting being called to order will each be allowed a three-minute allotment to address their concerns regarding items not posted on the agenda.

Sylvia Orozco, Artistic Director of Mexic-Arte – Request to have the matrix reviewed, as the end all be all, and does not stay the same year to year and is concerned with the constant fluctuations. Too much instability.

Ann Ciccollela, Artistic Director of Austin Shakespeare – Peer Panelist seemed to be skewed to support new groups, and looked more closely at the long standing groups

Louis Grachos, Executive Director of the Contemporary – The deep cuts are really hurting the smaller groups, and there needs to be more transparency. The Panel Reviews were poor, and a concern that the panelist were not prepared

Rudolfo Mendez, Artistic Director Ballet East Dance Company – The peer review panel was not as expected. The funding currently proposed would be detrimental to Ballet East.

Nataly Rock, Administrator for Xenia Rock – Would like to see how applicants are successful in the applications, like asking how many people attended in previous years for example as part of their application

Chris Cowden, Artistic Director of Women & Their Work – Score of 75 is considered adequate for the funding – and consider lower amount for Community Initiatives and Marketing and Promotion.

Acia Gray – Executive Artistic Director of Tapestry Dance Company – Concerned that the organizations that with the most history were most impacted. They are the roots of the arts community

Sarah Rucker, Owner Full Gallop – Working group on Equity and Inclusion with the Arts Commission to expand equity and inclusion riders within City of Austin and in particular Cultural Funding contracts. Inviting more community members to attend Arts Commission Meetings

Shea Little, Executive Director of Big Medium – Concerned about the percentage of funds awarded, Scored excellent throughout in the panel, but they still received a major reduction in funds.

Ann Graham, Executive Director of Texans for the Arts – Communication with the applicants as soon as we are aware that funds will be down earlier, rather than later.

Cookie Ruiz, Austin Arts Advocacy – Would like to have been notified earlier in the process to better plan for potential cuts. Please make the applicants as whole as much as you can. Increase transparency, sharing the Hotel Occupancy Tax receipts as they come in

Lacey Richter, Individual Artist – Wants to champion the bigger organizations that have supported her work in the past. Would like to have a better understanding of how funding is determined

Erin Gentry, Mass Gallery – Update on space loss, now have a new space, and is now concerned with the reduction of the funds, and as a volunteer run organization there aren't staff expenses to

Josh Green, Pump Project Artistic Director – Joining the group at POP on Springdale. Wants to support the revisions to funding allocations. Hopes that the funds for the Arts Space Assistance Program will continue.

Andria Bennett, Protos Media Arts – Not returning for funding in FY19 because they were not able to secure the needed space, and is moving out of the country to find a better city to support the work of the organization. Supports working with the Arts Advocacy Coalition for future improvement.
