For the purposes of this opportunity, historically underrepresented shall include any artist who identifies as African-American, Arab-American, Asian-American, LatinX, Pacific Islander, Indigenous Nations, LGBTQ, or a person with a disability. Should a semifinalist round be required, the Selection Panel will make every effort that at least 33% of semi-finalists identify with historical underrepresented communities."
