



**AUSTIN WATER OVERSIGHT COMMITTEE  
MINUTES**

**REGULAR MEETING  
7<sup>th</sup> of November 2019**

The Austin Water Oversight Committee met in a regular meeting on Thursday, November 7, 2019 at City Hall, Boards and Commission Room, 301 West 2<sup>nd</sup> Street in Austin, Texas.

Chair Paige Ellis called the committee meeting to order at 1:07 p.m.

**Citizen Communication: General**

Bobby Levinski, Save Our Springs (SOS) Alliance, requested to preview an idea to bring in Sharlene Leurig (Texas Water Trade) and others to give a presentation on broader financial models for various communities on how source water protection can be done especially in light of Texas legislature caps on revenues. He gave the committee a report that includes a recommendation for Austin Water to buy more water quality protection land, using the Clean Water State Revolving Fund.

**1. Discussion and approval of the 2020 Austin Water Oversight Committee meeting schedule**

Council Member Ellis seconded the motion. The item was approved on a 3-0-0-1 vote with Council Member Kitchen absent.

**2. Director's Report**

Director Greg Meszaros, Austin Water introduced Austin Water's leadership team and presented an overview of Austin Water's services and infrastructure to the committee. Report included an

overview of Austin's water supply and river rights, weather events and climate control, water management plan, conservation, Austin Water's strategic plan, innovative water strategies, and the wildlands.

Possible Action: (1) Council Committee wants access to Monthly Performance Dashboard; (2) they want staff to give a future presentation on water loss; (3) want to establish a partnership with the state to mitigate costs tied to the management and removal of zebra mussels; and (4) they want to help facilitate a meeting between Austin Water and Watershed Protection Department to help address zebra mussels at their source and not just at the pipes.

**3. Briefing about Austin Water affordability metrics**

David Anders, Assistant Director of Finance provided the briefing. Discussion included Austin Water's Affordability Plan.

Possible Action: Council Committee wants staff to incorporate affordability matrix as a key performance strategic indicator.

**4. Update on Austin Water Treatment Plants and Water Quality Status**

Rick Coronado, Assistant Director of Operations provided the briefing. Discussion included product quality and reliability on water and wastewater delivery plants.

Possible Action: (1) Council Committee wants an update on Redbud Isle; they want to voice their preference to do testing to catch things quickly and to make it on-going; and (2) a map of package plants that are in Travis County.

**5. Update on Planned Infrastructure Improvements**

Item was postponed to next meeting (February 4, 2020) to include water leakages.
