

**M/WBE Summary**

Participation subgoals stated in the solicitation were 1.9% African American; 9% Hispanic; 4.9% Native Asian; 15.8% WBE. The recommended firms provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.
