### **Posting Language**

Set a public hearing related to an application by MHP City Heights, Ltd., or an affiliated entity, for housing tax credits for a multi-family development that will be financed through the private activity bond program, to be known as City Heights, located at or near 4400 Nuckols Crossing Road, Austin, Texas, 78744, within the City (Suggested date: Thursday, August 27, 2020, Austin City Hall, 301 W. 2nd Street, Austin, Texas).

### **Fiscal Note**

This item has no fiscal impact.

### **Prior Council Action:**

February 6, 2020-Council approved a resolution of support for City Heights to the Texas Department of Housing and Community Affairs' 2020 9% Low Income Housing Tax Credit (LIHTC) round. Having not secured a 9% LIHTC award, City Heights will now pursue a 4% LIHTC award.

### **Council Committee, Boards and Commission Action:**

November 14, 2019-Austin Housing Finance Corporation Board approved negotiation and execution of a loan agreement with McDowell Housing Partners, LLC, or an affiliated entity in an amount not to exceed \$4,000,000 for a multifamily rental development to be known as City Heights.

June 11, 2020-Austin Housing Finance Corporation Board approved an inducement resolution for an allocation of up to \$22,000,000 in private activity volume cap multifamily non-recourse bonds to MHP City Heights, Ltd., or an affiliated entity, for a proposed affordable multifamily development to be known as City Heights.

### **Additional Backup Information:**

This action sets a public hearing to receive public comment on an application that will be (or has been) submitted to the Texas Department of Housing and Community Affairs (TDHCA). The Applicant, MHP City Heights, Ltd., or an affiliated entity, seeks funding for the Development through 4% Low Income Housing Tax Credits (LIHTC) and private activity bonds. After the public hearing, Council will consider a resolution about the proposed development. The property is located in Council District 2.

### **Proposed Development**

MHP City Heights, Ltd., which is an affiliate of McDowell Housing Partners, LLC, plans to develop a 179 unit multi-family development to be located at 4400 Nuckols Crossing Road, Austin, Texas, 78744. The community will be affordable to households earning at or below 80% of the Austin Median Family Income (MFI). The

development is proposed to be partially funded with 4% Low Income Housing Tax Credits and tax-exempt bonds issued by the Austin Housing Finance Corporation. Austin Housing Finance Corporation (AHFC) recently approved a loan of \$4,000,000 for the development.
