By this action, the City Council will ratify the property tax increase reflected in the Budget for Fiscal Year (FY) 2020-2021.

This action complies with the property tax ratification requirements mandated by the Legislature in 2007 and set forth in Local Government Code Section 102.007(c).

On July 30, 2020 Council approved the maximum property (ad valorem) tax rate it would consider adopting for FY 2020-2021 which is 53.35 per \$100 of taxable value. Council will set the actual rate at this maximum rate or lower. The actual rate will be determined upon approval of the FY 2020-2021 General Fund Operating and Capital Budgets as part of budget adoption.
