## **ORDINANCE NO.**

AN ORDINANCE ORDERING A GENERAL MUNICIPAL ELECTION TO 2 3 BE HELD IN THE CITY OF AUSTIN ON NOVEMBER 3, 2020, FOR THE 4 PURPOSE OF ELECTING CITY COUNCIL MEMBERS (SINGLE **MEMBER DISTRICTS) FOR DISTRICT 2, DISTRICT 4, DISTRICT 6,** 5 **DISTRICT 7, AND DISTRICT 10; ORDERING A SPECIAL ELECTION** 6 FOR THE PURPOSE OF SUBMITTING A PROPOSED TAX RATE THAT 7 EXCEEDS THE VOTER APPROVAL RATE FOR THE PURPOSE OF 8 FUNDING AND AUTHORIZING THE PROJECT CONNECT TRANSIT 9 SYSTEM; PROVIDING FOR THE CONDUCT OF THE MUNICIPAL 10 GENERAL AND SPECIAL ELECTIONS; AUTHORIZING THE CITY 11 **CLERK TO ENTER INTO JOINT ELECTION AGREEMENTS WITH** 12 **OTHER LOCAL POLITICAL SUBDIVISIONS AS MAY BE NECESSARY** 13 FOR **ORDERLY CONDUCT** OF THE **ELECTIONS:** 14 THE AND **DECLARING AN EMERGENCY.** 15

## 16 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN**:

PART 1. A general municipal election shall be held in the City of Austin on November 3, 2020. At the election there shall be elected by the qualified voters of the City five City Council Members (single member districts) for District 2, District 4, District 6, District 7, and District 10. The candidates for Districts 2, 4, 6, 7, and 10 shall meet all requirements, shall be residents of their respective districts, and shall be elected by majority vote of voters residing in each respective district.

PART 2. A special municipal election shall be held in the City on November 3, 2020, to submit to the voters of the City a proposed tax rate that exceeds the voter approval rate, for the purpose of funding and authorizing a fixed rail transit system known as Project Connect. The ballot shall be prepared to permit voting "For" or "Against" the Proposition:

32 for the purpose of providing funds for to implement a citywide traffic-33 easing rapid transit system, known as Project Connect, and to fund associated investments that encourage affordable housing along transit 34 corridors; to address traffic congestion, expand service for essential 35 workers, reduce <u>climate change</u> emissions, decrease traffic fatalities, 36 create jobs, and provide additional access to jobs, education, schools, 37 health care, jobs and to the airport; to include neighborhood supportive 38 affordable housing investments along transit corridors and the transit 39 system is to include a fixed rail and bus rapid transit system, including 40 associated roadway, bikeway, sidewalk, bike, and street lighting 41 42 improvements, park & ride hubs, on-demand neighborhood circulator shuttles, innovative customer technology; and improved access for 43 seniors and persons with disabilities,; and is to be operated by the 44 Capital Metropolitan Transportation Authority, expending its funds to 45 build, operate and maintain the fixed rail and bus rapid transit system; 46 the additional revenue raised by the tax rate is to be dedicated by the 47 48 <u>City</u> to an independent board to oversee and finance the acquisition, construction, equipping, and operations and maintenance of the rapid 49 transit system by providing funds for loans and grants to develop or 50 expand transportation within the City, and to finance the transit-51 52 supportiveed anti-displacement strategies related to Project Connect. Last year, the ad valorem tax rate in the City of Austin was \$0.4431 per 53 \$100 valuation. 54

**PART 3**. The elections shall be conducted between the hours of 7:00 a.m. and 7:00 p.m. The location of the main early voting polling place, the dates and hours for early voting, and the early voting clerk's official mailing address are provided in Exhibit A, attached and incorporated as a part of this ordinance.

PART 4. A direct electronic recording voting system, as the term is defined in Title
8 of the Texas Election Code, shall be used for early voting and for voting conducted
on election day. The central counting station is established at the Travis County
Elections Division, 5501 Airport Boulevard, Austin, Texas.

PART 5. Notice of these elections shall be given by posting and publishing a copy
of this ordinance in both English and Spanish. The notice and a copy of this

ordinance shall be posted, in both English and Spanish, in the office of the City Clerk and at the City Hall notice kiosk not later than the 21<sup>st</sup> day before election day. Notice of this election shall be published one time, not earlier than the 30<sup>th</sup> day before the date of the election or later than the 10<sup>th</sup> day before the date of the election, in a newspaper of general circulation in the City of Austin.

**PART 6.** In accordance with Chapter 271 of the Texas Election Code, the November 3, 2020 municipal elections may be held jointly with the various political subdivisions that share territory with the City of Austin and that are holding elections on that day. The City Clerk may enter and sign joint election agreements with other political subdivisions for this purpose, and their terms as stated in the agreements are hereby adopted.

76 PART 7. The Council finds that the need to immediately begin required 77 preparations for these elections constitutes an emergency. Because of this 78 emergency, this ordinance takes effect immediately on its passage for the immediate 79 preservation of the public peace, health, and safety.
