# Posting Language

Authorize an amendment to an existing contract with GT Distributors, Inc., to provide public safety vehicle light bars and siren equipment, parts, and accessories, for an increase in the amount of \$81,250, for a revised total contract amount not to exceed \$406,250.

# Additional Backup Information:

The proposed amendment is to provide Communication Technology Management, Wireless Communication Services Division (WCSD), with a constant source of public safety vehicle light bars, siren equipment, parts, and accessories. Light bars and siren equipment are used to alert traffic of potentially hazardous conditions, fast-moving vehicles, and lane closures.

Due to unanticipated needs, there is insufficient spending authority to maintain the contract through its term and this proposed amendment is needed to provide for the continued purchase of equipment until a new contract can be put in place. The State of Texas Move Over Law was recently amended to include all public

service vehicles. To be in compliance with the law, WCSD is installing emergency lighting in additional City vehicles including ones for Austin Energy, Austin Water, Public Works, and Watershed Protection Department.

The contract is necessary to provide WCSD with a reliable and continuous source of equipment, repair parts, and replacement parts for public safety and service vehicles.
