Additional Backup Information:

The Action Plan serves as the City's application to receive HUD formula grants for Fiscal Year 2020-2021. In Fiscal Year 2020-21, the City of Austin expects to receive continued federal funding through four U.S. Housing and Urban Development (HUD) formula grants: Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), Emergency Solutions Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA). In order to receive these HUD grants, the City must submit an annual Action Plan that provides an overview of community needs, resources, priorities, and proposed housing, community development, economic development, homelessness services, and public services activities.

This action complies with the City of Austin's Citizen Participation Plan (CPP), as amended, and with program waivers authorized by HUD. The waivers are allowed to help prevent the spread of COVID-19 and to facilitate

assistance to communities and households economically impacted by COVID-19.
