
# OUR MISSION




**Austin Outside's mission is to champion outdoor places for all throughout Greater Austin.**

# OUR VALUES




Everyone has the right to accessible parks and green spaces within a ¼ mile of their home.

Dear Mayor Adler and Austin City Council Members,

Austin is on the cusp of transformational change in the ways we get around. Austinites new and old are looking for safer, healthier, more pleasant transportation options besides being stuck in traffic behind a steering wheel. The pandemic has laid bare both the clear need and the public appetite for a more equitable transportation system. **That's why we urge you to seize this historic opportunity and, in addition to Project Connect, approve a \$750 million Safe Mobility Bond for public vote this November to fund a citywide network of sidewalks, bikeways, urban trails, and safe streets for all.**

Such a bond will be Austin's chance to achieve its progressive mobility goals and transform our city into one where everyone is safe on our streets and is free to choose how they move around. Walking, bicycling, and using a mobility device such as a wheelchair should be enjoyable, convenient, safe ways for people of all ages, abilities, and backgrounds to get where they need to go, whether commuting to work, taking a safe route to school, running errands, visiting a friend, or enjoying nature.

Austin has already set bold goals to achieve these visions. The Austin Strategic Mobility Plan aims for 50 percent of trips to be made in ways other than driving alone by 2039. Through its Vision Zero program, Austin has committed to eliminating traffic deaths and serious injuries by 2025. And the Community Climate Plan calls for reducing carbon emissions to net-zero by 2050. Now we must fund these goals.

### BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

The City Manager is directed to present to the Council, with sufficient time for it to consider and, if desired, place on the November 2020 ballot, measures to enhance funding for displacement mitigation and fund implementation of the following active transportation improvements identified in the Austin Strategic Mobility Plan:

- Sidewalks: high- and very-high priority sidewalk segments and address ADA barriers and gaps in the sidewalk system
- Safe Routes to Schools Plans
- Bikeways: All Ages and Abilities bicycle facilities, including the Bicycle Priority Network
- Urban Trails: Tier I urban trails and identify alignments and develop designs for Tier II urban trails
- Safety/Vision Zero: Projects that reduce conflicts and improve safety for all users on the High-Injury Network and at high-risk locations by systematically implementing both major reconstruction and rapid implementation of low-cost, high-impact engineering countermeasures
- Transit Enhancement Program: Projects that improve the speed

# WHY AN ACTIVE TRANS BOND VOTE IN NOVEMBER?

- Likely historic high voter turnout
- Recent changes in public mobility choices and perspectives
- Meet various City goals on time
  - Eg. 50% trips not taken by driving alone by 2039 (ASMP)
- 2016 Local Mobility bonds for sidewalks, bike lanes and trails will be fully committed by 2020
