Committee Recommendation: Not comfortable with the scale of the addition, the Committee recommended increasing the distance between the existing and new walls and mansard turrets, consider a different color scheme that will not distract the eye from the historic building.

Staff Recommendation: Refer the case back to the Certificate of Appropriateness Review Committee for further consultations on the scale of the addition and its relation to the historic building.
