To speak remotely at the Emma S. Barrientos Mexican American Cultural Center Advisory Board on September 2, 2020 Meeting, residents must:

- Speakers must call in at least 15 minutes prior to meeting start in order to speak, late callers will not be accepted and will not be able to speak.
- Speakers will be placed in a queue until their time to speak.
