

AUSTIN CITY COUNCIL MINUTES

WORK SESSION MEETING TUESDAY, JULY 28, 2020

The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, July 28, 2020, via. Videoconference.

Mayor Adler called the Council Meeting to order at 9:02 a.m.

BRIEFINGS:

B1. Briefing on Covid-19 related matters, including a report on nursing homes.

Presentation was made by Stephanie Hayden, Director, Austin Public Health Department, Dr. Mark Escott, Interim Medical Director and Stacey Chang, Executive Director, Design Institute for Health, Dell Medical School, University of Texas

Direction was given to staff to ask for clarification from the Attorney General regarding the release of data relating to nursing facilities; provide clarification to the public on the need adhere to social distance rules with our extended family members; provide a chart for contact tracing and impact of increasing the amount of contact tracing; provide information on the number of cases involving day care centers.

Approve ratification of an agreement with Caritas of Austin for the ImpACT Program to provide permanent supportive housing to individuals who have experienced chronic homelessness and are the highest utilizers of crisis services in an amount not to exceed \$110,079 for the term July 1, 2020 through September 30, 2020.
- 59. Authorize an amendment to an existing contract with Overdrive Inc., for continued digital content materials and services that would increase the contract amount by \$10,710,000 and extend the term by three years, for a revised total contract amount not to exceed \$16,020,201. (Note: This amendment was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods and services required for this contract there were no subcontracting opportunities identified; therefore, no subcontracting goals were established).
