**SUBJECT:** COVID-19 Economic Recovery Programs Update

This memorandum summarizes the City of Austin's progress implementing several programs that the Austin City Council adopted through <u>Resolution No. 20200326-088</u>, <u>Resolution No. 20200409-086</u>, <u>Resolution No. 20200423-040</u>, <u>Resolution No. 20200507-023</u>, and <u>Resolution No. 20200604-040</u>. To date, the City distributed more than \$37.5 million to support and sustain local businesses, non-profit organizations, and residents that are financially impacted by the global COVID-19 pandemic. Additionally, more than \$20 million is either currently being distributed or will soon be distributed in the coming weeks. Table 1 on the next page shows the implementation schedule for all economic recovery programs. The Program Development Matrix in Appendix A provides more information on progress to date for each program. Appendix B features personal accounts from grant and loan recipients describing the impacts of these grant programs in their own words. Appendix C includes a list of all music businesses and live music venues that received a grant or loan through one of the programs mentioned in this update.

## Program Impact

The City of Austin distributed more than \$37.5 million to support and sustain local businesses, non-profit organizations, and residents that are financially impacted by the global COVID-19 pandemic, and more than \$20 million in additional support is either currently being distributed or will soon be distributed through various programs – such as the Relief of Emergency Needs for Tenants (RENT) program, the Relief in a State of Emergency (RISE) Fund, the Austin Civilian Conservation Corps, and the relaunched Austin Non-Profit Relief Grant. More information about these programs is either currently available or will soon be available online at <u>ATXrecovers.com</u>.

To the greatest extent possible, City staff continue to prioritize equity, need, and vulnerability as they create and implement these programs. Equity strategies used by City staff include circulating press releases and promotional materials in multiple languages; allowing applicants to complete and submit their applications in multiple languages; offering one-on-one application assistance to anyone who needs support; and scoring applications to account for demographic factors including race, ethnicity, and gender.

Below are summaries of each economic recovery program's impacts on the Austin community.

- The <u>Austin Childcare Provider Relief Fund</u> awarded \$1.05 million in grants to 72 of 120 applicants. Sixtyeight recipients were center-based childcare providers and four were family care childcare providers. These providers collectively served 1,557 children receiving childcare subsidies.
- The <u>Austin Creative Space Disaster Relief Program</u> awarded \$987,943 in grants to 32 of 65 applicants. Collectively applicants requested \$3.7 million in financial assistance, which was nearly four times the \$1 million available in the fund. Grant recipients included live music venues (12), arts nonprofits (11), theaters or performance venues (7), museums or art galleries (1), and independent artists (1).

- The <u>Austin Creative Worker Relief Grant</u> awarded \$3.36 million to 1,877 of 5,502 applicants. Half of the funds was awarded to the 907 applicants that scored highest on the program's equity matrix. The remaining funds were distributed through a lottery, resulting in 970 additional awards.
- The <u>Austin Economic Injury Bridge Loan Program</u> awarded \$645,000 in small business loans to 19 of 70 approved applicants. Fifty-one applicants declined the loan offer either due to acceptance of other federal disaster assistance or non-acceptance of loan terms.
- The <u>Austin Music Disaster Relief Fund</u> awarded \$1.5 million in grants to 1,497 performing musicians impacted by the COVID-19 pandemic. These funds were awarded on a first come, first serve basis.
- The <u>Austin Non-Profit Relief Grant</u> awarded \$3.6 million in grants to 221 to non-profit organizations impacted by the COVID-19 pandemic. Approximately \$2.4 million remains in the fund, which will be distributed in late September through the relaunched Austin Non-Profit Relief Grant with revised program eligibility. City staff anticipate applicants' request for aid will exceed the remaining program balance.
- The <u>Austin Small Business Relief Grant</u> awarded \$16.2 million in grants to 885 of 2,526 applicants. Applicants submitted more than \$120 million in eligible reimbursement requests for this program, which was nearly seven times the total program fund.
- The <u>Relief of Emergency Needs for Tenants (RENT)</u> pilot awarded \$1.27 million in May, serving 1,681 households by providing direct rental assistance to landlords for one month.
- The <u>Relief in a State of Emergency (RISE) Fund</u> awarded \$9.2 million in direct support to more than 7,800 households.
