WHEREAS, the City Manager appoints Farah Ahmed to fill the vacancy on the Commission created when Commissioner Ronald Morgan resigns from his appointment on December 20, 2020; and

WHEREAS, the City Manager appoints Ms. Ahmed to fill the unexpired term ending December 6, 2020 and Ms. Ahmed meets the statutory prerequisites for appointment to this position; and
