AN ORDINANCE AMENDING THE FISCAL YEAR 2020-2021 PARKS AND RECREATION DEPARTMENT OPERATING BUDGET SPECIAL REVENUE FUND OPERATING BUDGET (ORDINANCE NO. 20200812-001) TO ACCEPT AND APPROPRIATE AN ESTIMATED \$250,000 FROM THE TRAIL OF LIGHTS FOUNDATION FOR CITY EXPENSES AND SERVICES; AND AUTHORIZING THE WAIVER OF CERTAIN FEES AND REQUIREMENTS FOR THE 2020 TRAIL OF LIGHTS IN AN AMOUNT ESTIMATED AT \$200,000.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Council waives and reimburses certain fees and requirements for the 2020 Trail of Lights event as follows:

PART 2. On March 1, 2012, Council authorized negotiation and execution of a cosponsorship agreement with the Run Tex Foundation for the 2012 Trail of Lights event. On March 21, 2013, City Council directed staff to negotiate and execute a five-year agreement for the Trail of Lights event, which was assigned to the Trail of Lights Foundation after City Council action in August 2013. On October 15, 2015, City Council authorized a 5 year co-sponsorship agreement continuing the event through the end of calender year 2022.

PART 3. Council accepts an estimated amount of \$250,000 from the Trail of Lights Foundation to defray City costs associated with the Trail of Lights event.
