To speak remotely at the November 13th Austin Integrated Water Resource Planning Community Task Force Meeting, residents must:

4. VOTING ITEMS

- a. Recommend approval of an ordinance amending City Code Chapter 6-4 (Water Conservation) and City Code Chapter 15-9 (Utility Regulations) related to: the assessment of administrative penalties and ineligibility for an evaporative loss credit on wastewater charges for failure to submit cooling tower water efficiency registration and inspection reports; the creation of an offense for submitting a false report or tampering with readout and reporting devices, the addition of efficiency performance standards for cooling tower drift eliminators; and a requirement to use of biocides in cooling tower water to increase water efficiency and protect public health.
- b. Recommend approval of 1) an ordinance to establish Chapter 15-13 of the Austin City Code regarding treatment, monitoring, and reporting regulations for Onsite Water Reuse Systems and 2) a pilot incentive program to encourage the development of local, sustainable water supplies using alternative source waters at building or neighborhood scale for non-potable uses.
