

M/WBE Summary

Public notice was given for this solicitation, CLMC798 Dalton Lane Site Utilities and Service Center Improvements, through the City's Vendor Connection web portal. Two bids were received and opened on September 24, 2020. Of the two bids received none of the firms were certified MBE/WBE. PGC General Contractors, LLC submitted the lowest responsive bid including an alternate of \$247,000 and an allowance of \$80,000:
