Public notice was given for this solicitation CLMC827, South Lamar Boulevard Corridor - Riverside Dr. to Barton Springs Rd., through the City's Vendor Connection web portal. Six bids were received and opened on 20 November 2020. Of the six of bids received two bids were from MBE/WBE certified firms. DeNucci Constructors, LLC submitted the lowest responsive bid including allowances of \$345,000 and an alternate of \$112,960:
