ASM was notified of the emergency repair to approve expenditure. Today, VSilas, GM received approval from Tony to proceed with the repair. The estimated expense was \$2249.50 however a final expense will be forthcoming when the work is completed. Entech is currently in the MYEC working on the repair.
