Posting Language

Ratify Amendment No. 3 to the agreement with DBG Austin Hotel LLC, for the City to occupy the real property located at 3105 North Interstate Highway 35, Austin, Texas, 78753 for emergency housing, isolation, and support services related to COVID-19 to extend the option period by three additional one-month terms, for an additional amount not to exceed \$340,200 and for a total contract amount not to exceed \$1,288,980.

Additional Backup Information:

On May 7, City Council approved \$234,000.00 for the temporary occupancy of the property beginning in April 2020 and on September 17, City Council approved an additional \$714,780 for the extended occupancy of the property until December 31, 2020 for a total of \$948,780.00.

This action ratifies Amendment No. 3 to the Emergency Temporary Occupancy agreement with DBG Austin Hotel LLC to occupy the property for emergency housing, isolation, and support services related to COVID-19. The agreement will include the use of 65 guest rooms and surrounding parking lot area. The amendment shall extend the option period bythree (3) additional one-month terms at a rate not to exceed \$340,200.00 (daily rate of \$3,780.00) for a total contract amount not to exceed \$1,288,980.

The City Manager for the City of Austin, or designee, has the authority to negotiate and execute ministerial or administrative amendments to this Agreement without further action of the City Council. Any amendment that

would constitute a substantive modification to the Agreement must be approved by the City Council. The health of Austin and Travis County residents and visitors is our highest priority.
