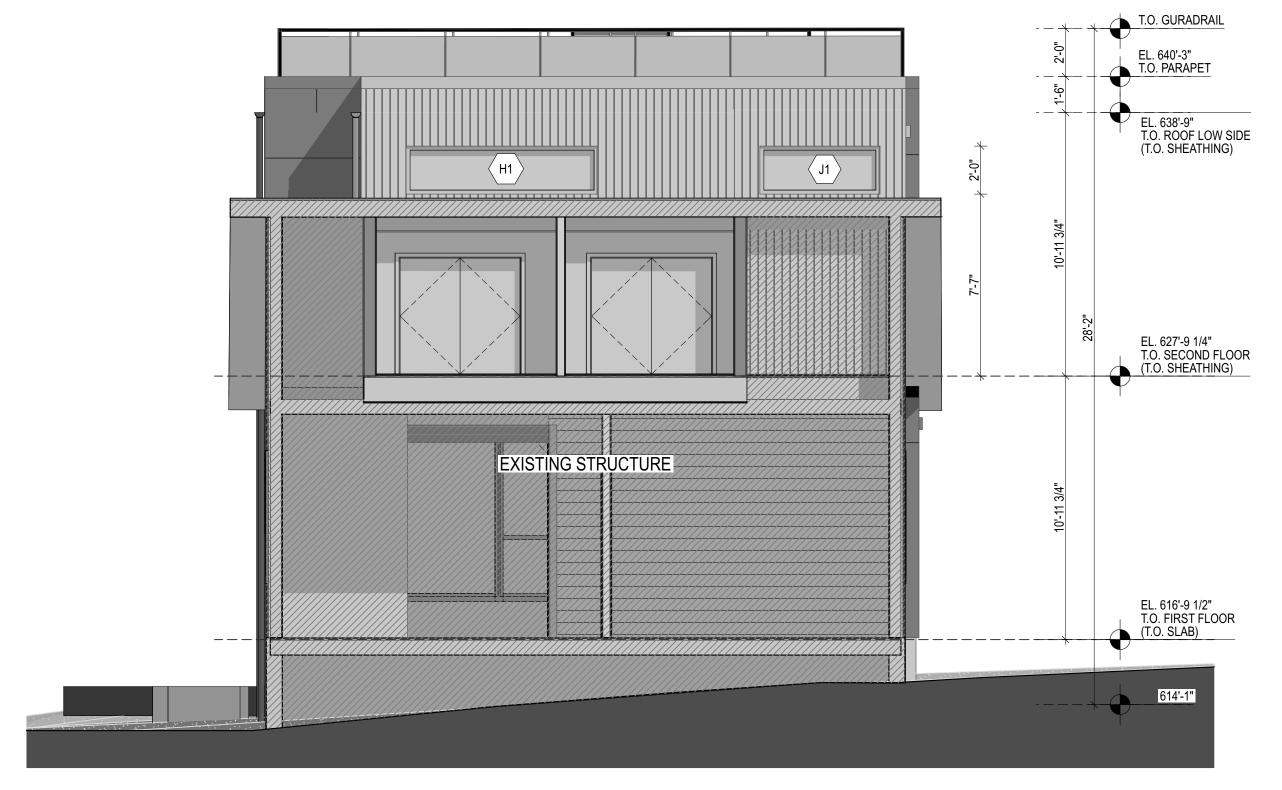

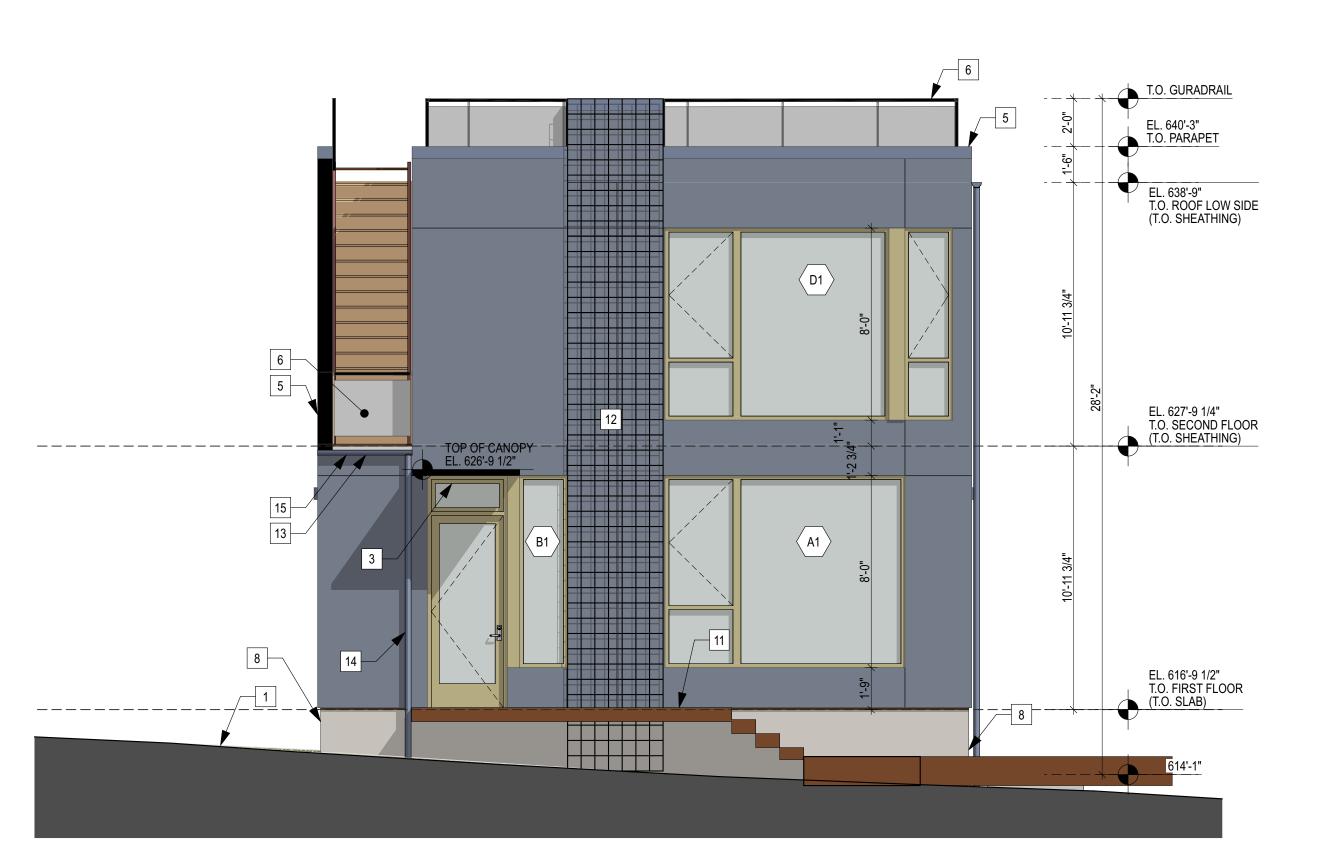






SOUTH ELEVATION EXISITNG

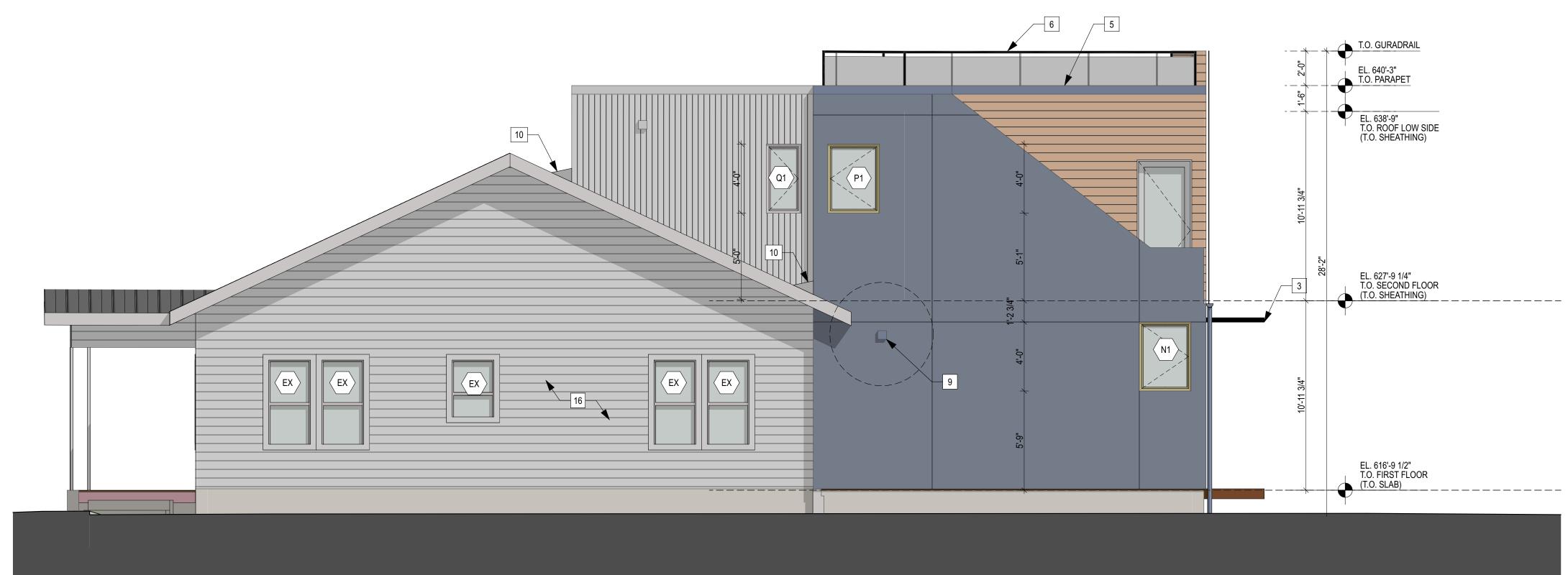

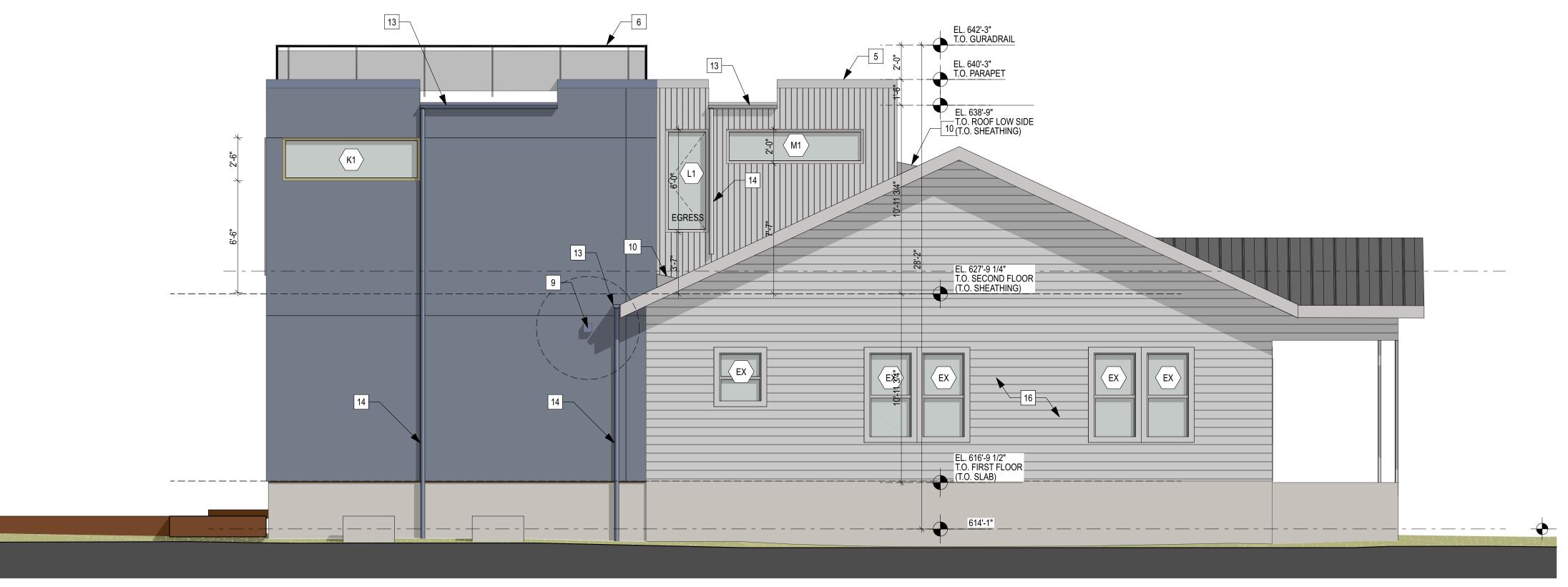
