Posting Language

Authorize award of a multi-term contract with United Electronic Recycling, LLC, to provide electronics recycling, for up to five years for an estimated revenue of \$330,000.

(Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. For the services required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established).

Fiscal Note

Estimated net revenue will be allocated to the Fiscal Year 2020-2021 Operating Budget of Austin Resource Recovery. Net revenue for the remaining contract terms will be available in future budgets.

Purchasing Language:

The Purchasing Office issued an Invitation for Bids (IFB) 1500 SLW1045 for these services. The solicitation issued on August 24, 2020 and it closed on September 17, 2020. Of the six offers received, the recommended contractor submitted the highest responsive offer. A complete solicitation package, including a tabulation of the bids received, is available for viewing on the City's Financial Services website, Austin Finance Online.

Council Committee, Boards and Commission Action:

January 13, 2021 - Recommended unanimously by the Zero Waste Advisory Commission on a 9-0 vote, with two vacancies.

Additional Backup Information:

The contract will provide the pickup, transportation, and recycling of computers and laptops. Austin Resource Recovery provides specialized waste diversion and disposal services through the Resource Recovery Center

and Household Hazardous Waste Facility, collectively known as the RRDOC, to protect the environment and conserve resources. Residents and City departments utilize the RRDOC to drop off various electronic recyclables.

The contractor must recycle the materials in an environmentally sound manner in accordance with the e-Stewards Standard for Responsible Recycling of Electronic Equipment of the Basel Action Network and in compliance with all federal, state, and local laws.

The City estimates collection of over 1,000 tons of electronic recyclable materials from the RRDOC annually. The contract will continue diverting these materials from landfills, maximize the overall cost-effectiveness of the processes described above, promote the City of Austin's Zero Waste goals, and enhance awareness of recycling.

The current contract expires on April 12, 2021. The requested authorization amount was determined using departmental estimates based on historical drop-off quantities and anticipated future usage. The recommended contractor is not the current provider for these services.
