The Equity Office helps normalize, organize, and operational race-forward efforts across city departments


In Strategic Direction 2023, "Equity" is not a separate effort, but infused throughout




#### **Historic Cultural Funding**



Data gathered from past and current contractors shows an acute disparity in the distribution of funds. In FY20 alone, Black cultural contractors account for 5% of total dollars awarded and other BIPOC contractors account for only 20%. White cultural contractors account of the majority for funds awarded at 54%. This inequitable distribution of City funds, if not corrected, would further exacerbate the economic crisis facing many of the City's most vulnerable cultural contractors.

## Strategic Themes

#### Pandemic / Pivoting

- Moved up pre-contract & final report submission due dates for cultural contractors -incentivized early completion
- ADA quiz no longer required every year
- Reduced # of questions in final report questionnaire
- Developed automated insurance requirements forms
- Created videos for pre-contract orientation/final reports
- Working closely with Office of Design and Delivery to improve contract management efficiency and ease admin requirements
- Created and distributed CARES Act (over \$8.4M through 3,566 unique grants to creative individuals and orgs) and SAVES funds (\$5M for live music)
- Facilitated focus groups with creative community to help inform Austin's Regional Recovery Plan
- Included two artistic projects in the Austin Civilian Conservation Corps and assisted with Black Austin Matters/Black Artists Matter projects
- •Staff wearing multiple hats, working double duty, two CAD vacancies, reimagining the Cultural Funding Process and administering 600+ cultural contracts; Finance and Purchasing overloaded Citywide


