Item of concern: #61

Requirements: The purpose of this briefing is to highlight specific constituent comments involving a specific item on this week's agenda. The requirements are that have been an overwhelming majority of correspondence to the district office from constituents that are voicing whether they are for or against the item number listed above.

Summation: The majority of correspondence featured here are from constituents has been against Item #61 hotel purchase in North Austin. These statements came via email and phone call from constituents that live in or around the area being discussed. The purpose of this briefing is to focus on the impact to businesses and patrons.

Constituent Comments

transportation, no grocery stores close by, no access to jobs and will affect the property		
value of all the surrounding businesses. I'm not against finding housing for the		
homeless, but the issues I stated before should be taken into consideration. This is a		
knee jerk reaction to a complex problem. Please reject this proposal when it comes for a		
vote in February.		

Any plan for helping people must begin with holding individuals accountable for improvement. Fear of being accused of criminalizing homeless activity or restricting the right to be homeless, or to use drugs, or to panhandle encourages permissive policies that enable homelessness and self-destructive behavior. If the City of Austin does not change the culture and laws, and if they mismanage this building's operation and the screening of who is allowed in, this will just be another failure. A helping hand is great, but not if it does not come with forcing responsible behavior. As a business owner near the Candlewood Suites hotel on Pecan Park I do not want to see a potential failed housing assistance property near so many residential neighborhoods. Here is an example of improperly considered efforts; good intentions are great, but you have to move slowly to assemble resources and be prepared to manage properly before you jump into an endeavor such as this. If changing the outcome of the vote to purchase and transform the Candlewood suites into a homeless shelter becomes inevitable, would it be possible to fight for admendments or obtain some compensation for the residents in the surrounding communities. Several studies I've reviewed say that property values can decline as much as 10% if they are within a mile of a Homeless shelter. This is through no fault of the residents that property values would decline between \$20,000-\$30,000 per home given that the average home in the area is in the \$225,000 - \$350,000 range. In Pecan Park Garden Estates alone there are over 100 housing units. I dont know if a class action lawsuit against the city is an option but I do believe an injustice has been done to our local surrounding businesses and residents should this transaction come to fruition. Aside from that anything that could assist in easing the minds of residents such as increased security or a demand for strict vetting for those homeless that are accepted would be ideal . Im sure families that have fallen on ill fortune and could not afford rent or mortgage should take precedence over a mentally ill or drug addicted homeless person. My name is Cristina Gonzalez and I am originally from McAllen, Texas. I am a first-generation college graduate and moved to Austin in 2014 to attend law school. I am currently employed as an attorney in Austin and was blessed to have the opportunity to purchase my first home this past December. I was informed today regarding the City's plans to purchase the Candlewood Suites with the intention of providing housing for the homeless population. While I think all Austinites would like to see a compassionate solution to the homeless problem, I do not think a single person would be pleased with a homeless shelter being situated .2 miles from their home. I moved to this neighborhood in Anderson Mill because I felt it was safe to live as a single female and to eventually grow a family. Several homes in this neighborhood are directly in front of the hotel. I can't imagine a single one of you would feel comfortable walking the neighborhood trails in the evenings alone. Much less would I believe you would feel comfortable with your children playing directly in front of a homeless shelter. and old families. They all walk around their neighborhood to exercise, spend time with		
their kids, and walk their dogs without any worry but now they have to watch their		
backs. They have already slept in my restaurant patio, stolen my bicycle and tv that was		
on the patio, came into the restaurant and stole our lobby iPad and even some of our cars		
have been broken into. Candlewood is only one fence away from everybody. This		
homeless shelter is 947 ft away from Westwood high school. It is too close. We just		
don't believe this particular location is the answer. Please reconsider. Thank you so		
much.		

Conclusion: Based on review of the total constituent correspondence that has come in to-date, 100% of business owners or concerned business patrons are against item #61 – the purchase of the Candlewood Suites on Pecan Park. The majority of the opposing constituents would like to be notified of major real estate transactions in the area and, more time for discussion and input on the project before the approval of the purchase is proposed.
