Community members will be allowed to listen to the meeting via telephone but do not participate in the meeting. This is a virtual meeting; no in-person input will be allowed. The opportunity for public input will occur at a subsequent meeting of the Historic Landmark Commission. **All participants must register in advance (no later than 12:00 noon on Monday, February 8, 2021 to be notified of the call-in number and other instructions).**

To listen to or participate in the Architectural Review Committee meeting, all persons must:

- Speakers must call in at least 15 minutes prior to meeting start time in order to speak, late callers will not be accepted and will not be able to speak.
- Speakers will be placed in a queue until their time to speak.
