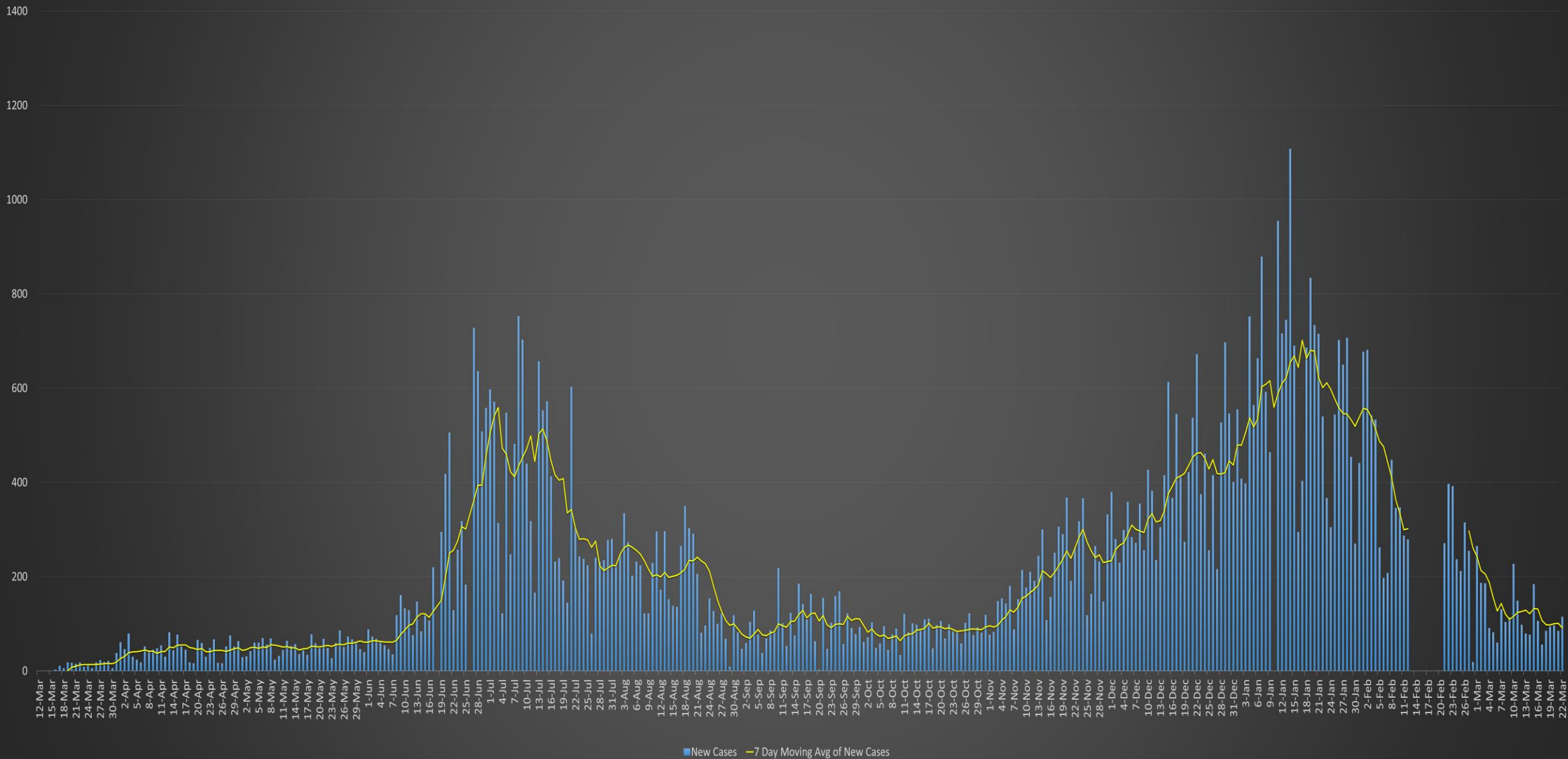

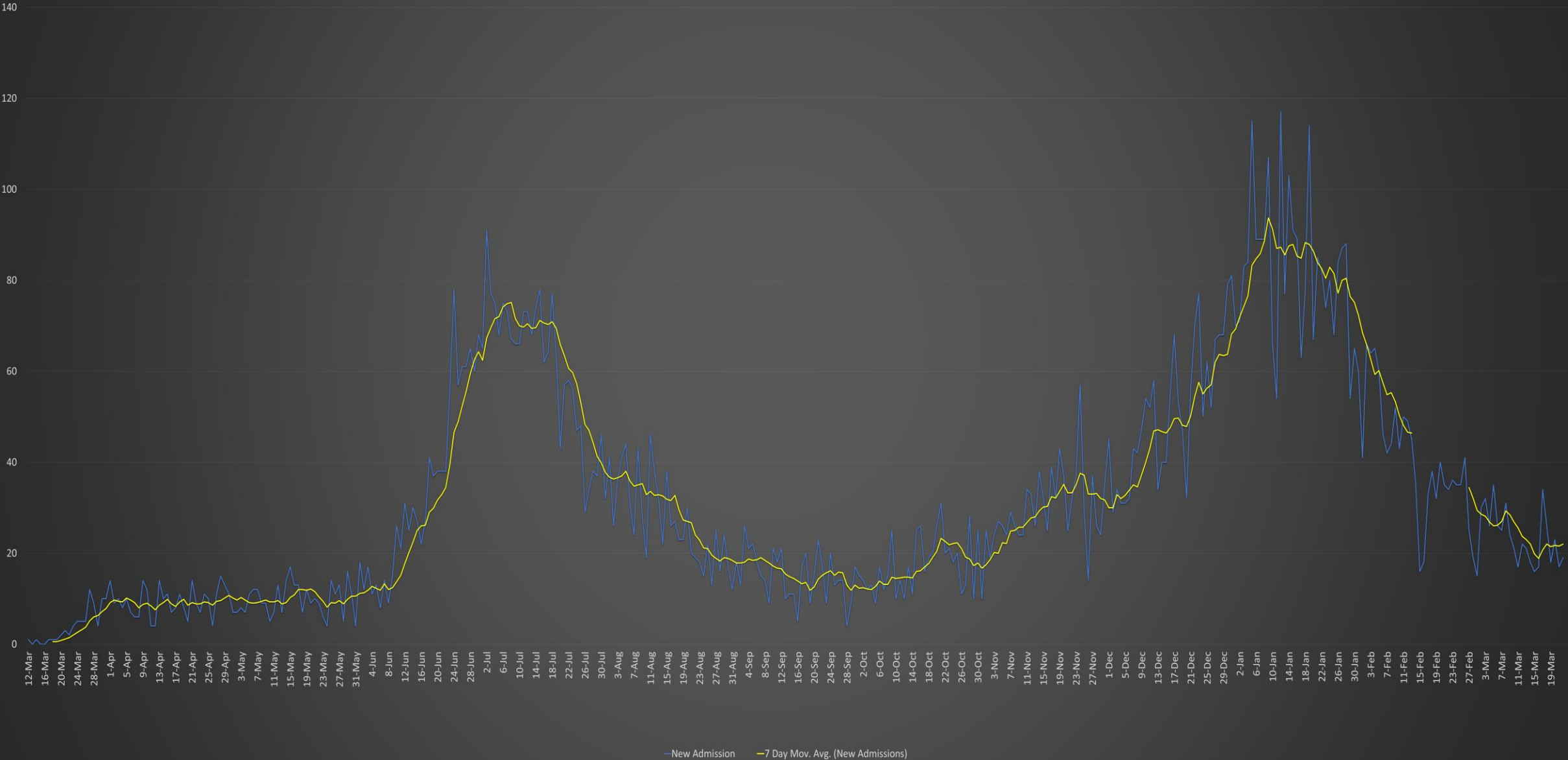

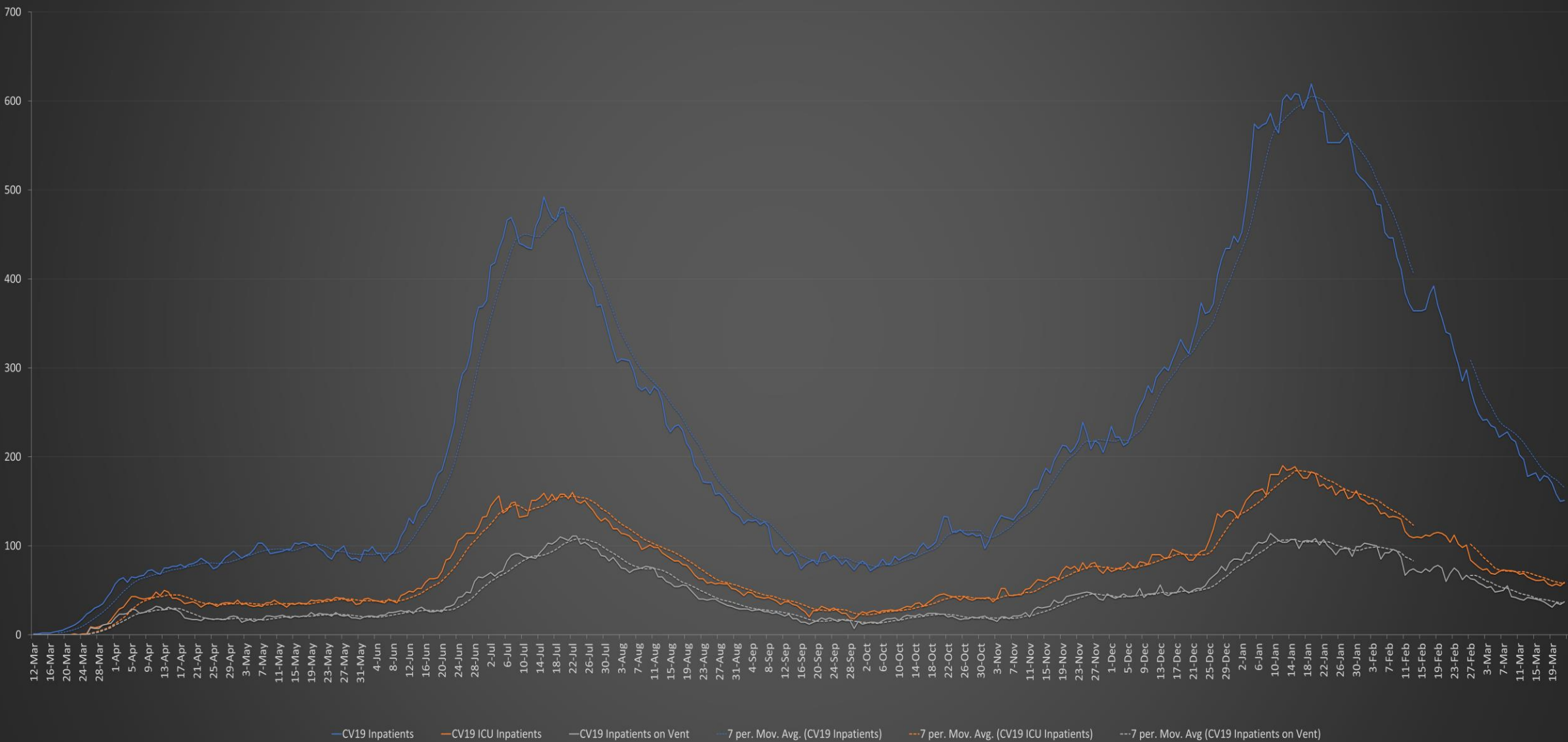
COVID-19 Travis County New Confirmed Cases



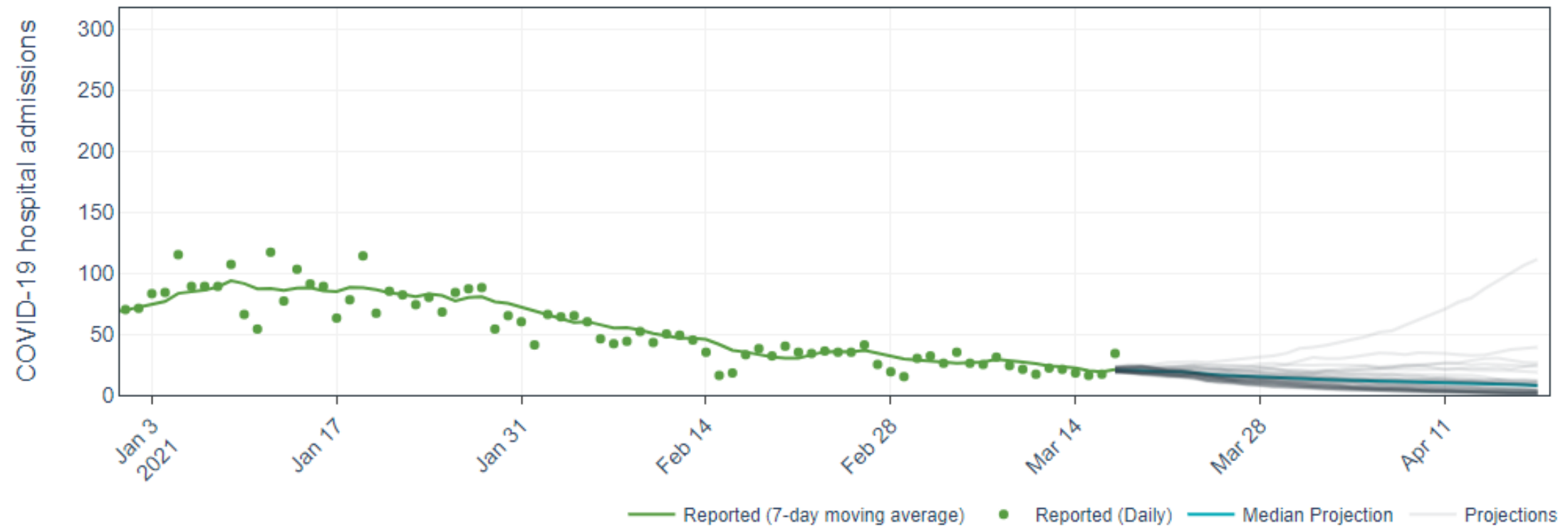
COVID-19 Austin MSA New Admissions



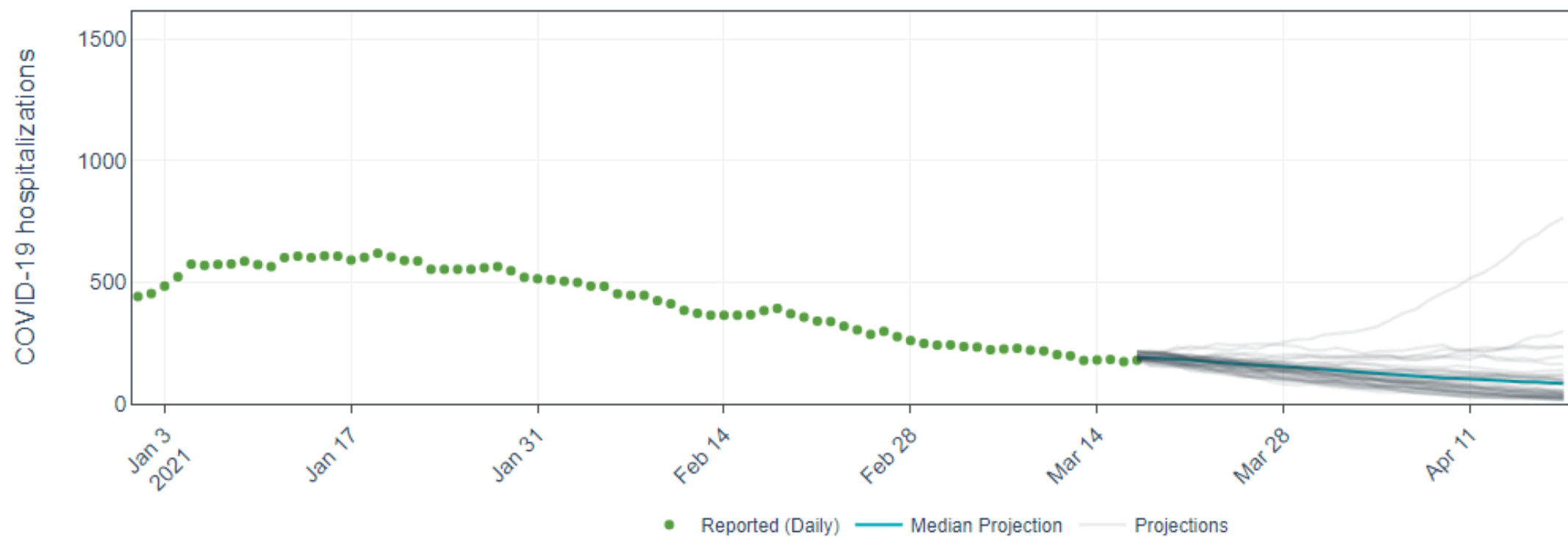
COVID-19 AUSTIN MSA CURRENT HOSPITALIZATIONS, ICU ADMISSIONS, AND VENTILATOR USE



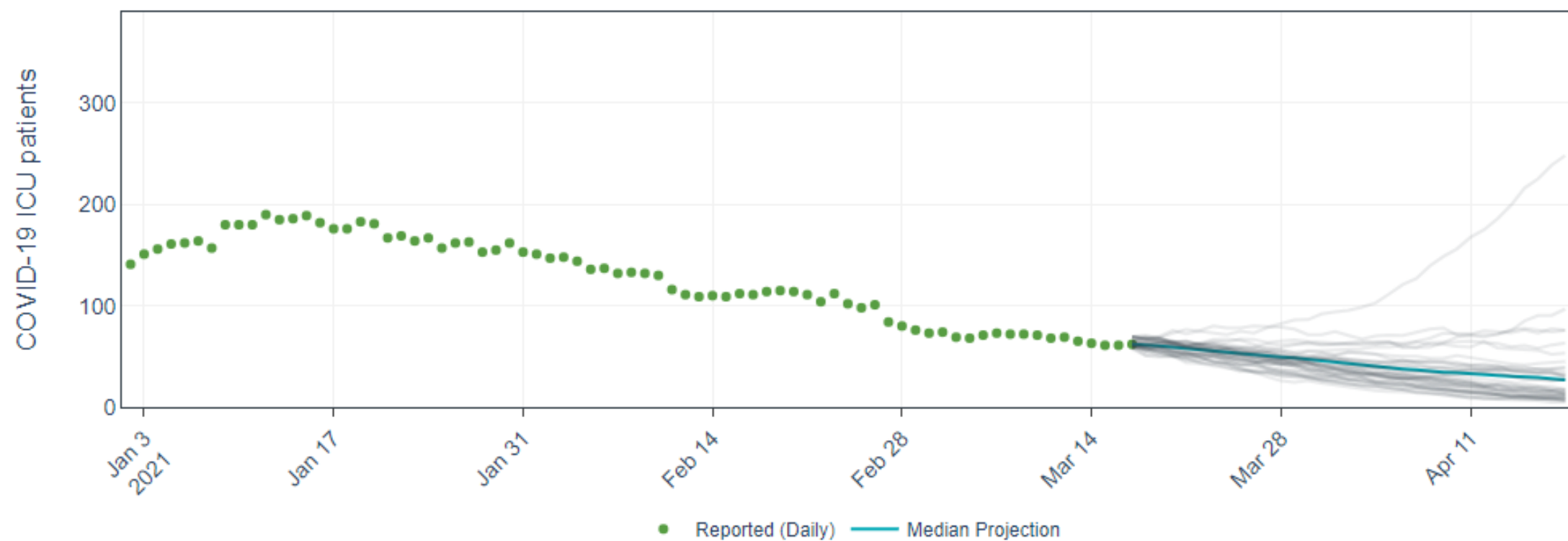
Daily COVID-19 Hospital Admissions in the Austin-Round Rock MSA (7 day moving average)



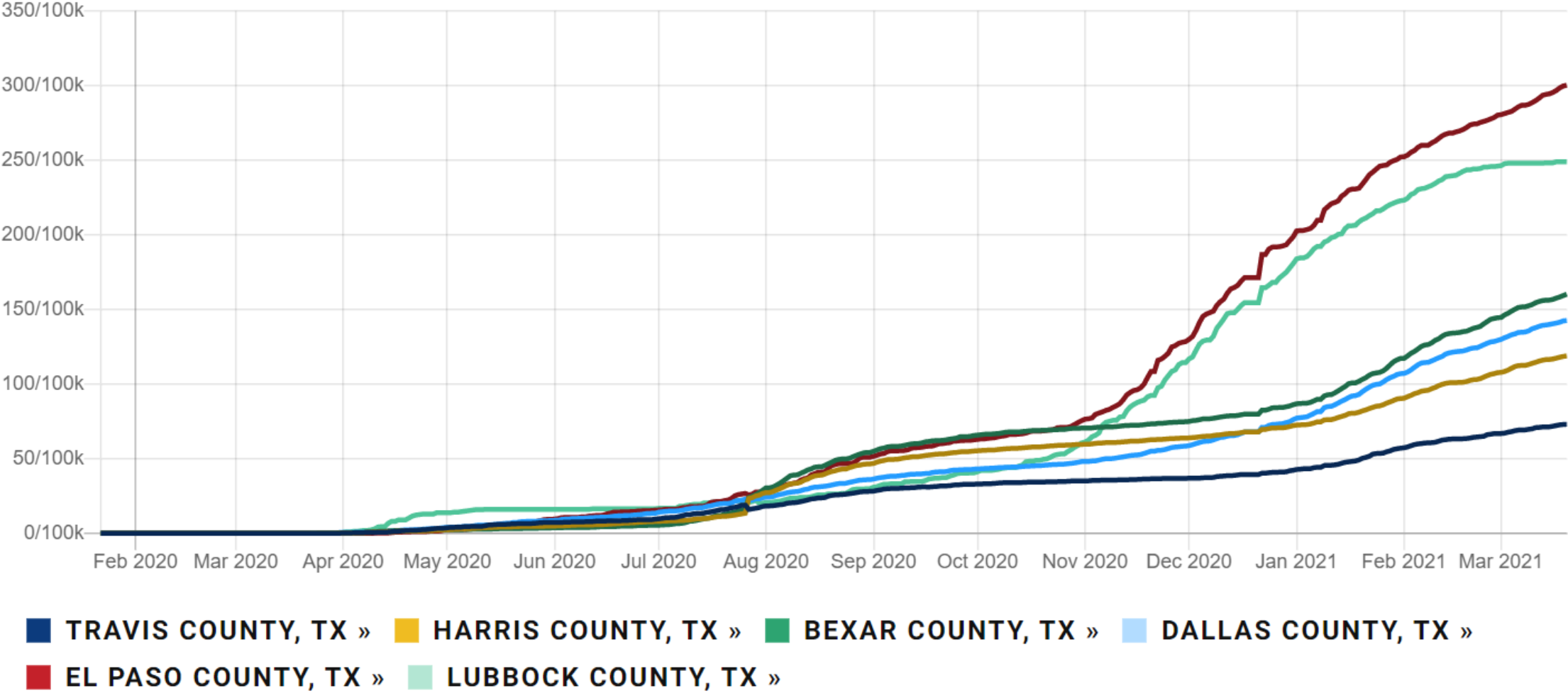
Daily COVID-19 Hospitalizations in the Austin-Round Rock MSA



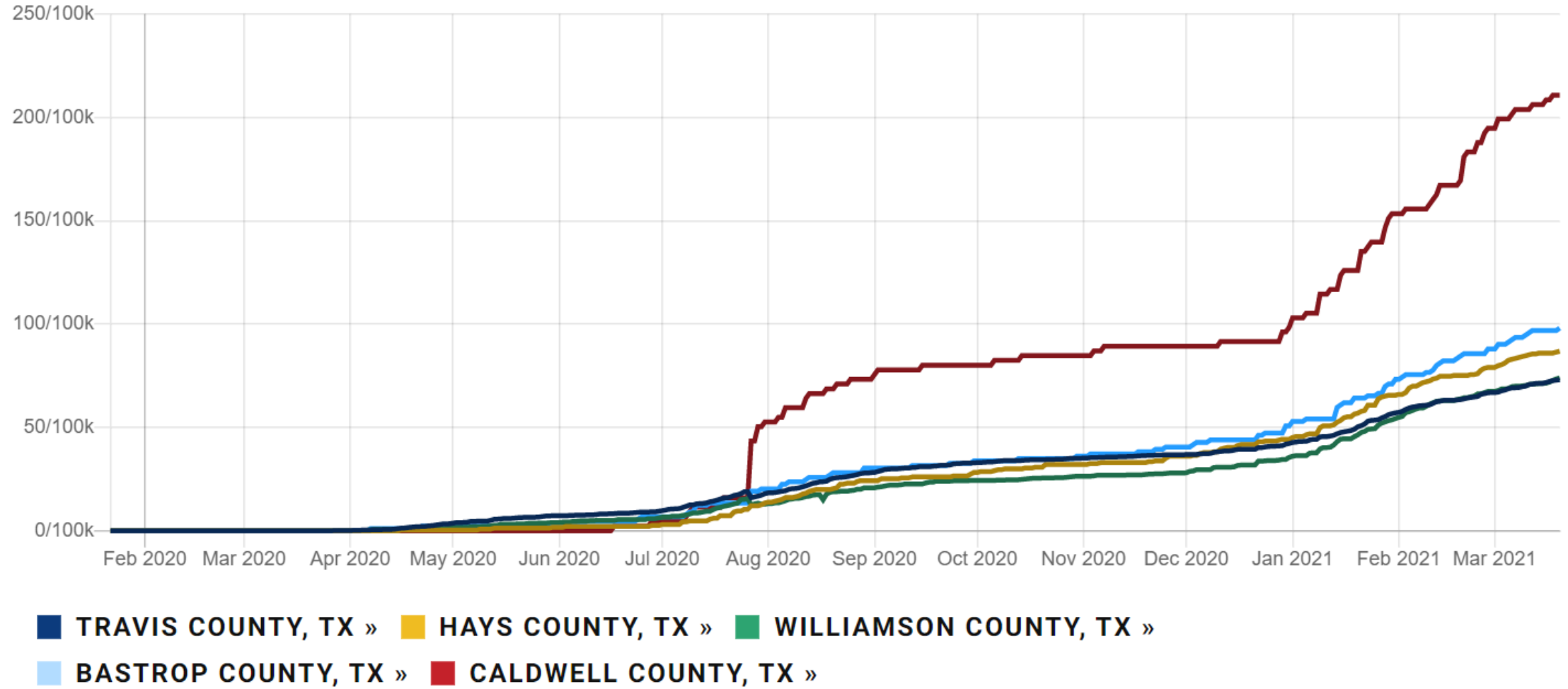
Daily COVID-19 ICU patients in the Austin-Round Rock MSA



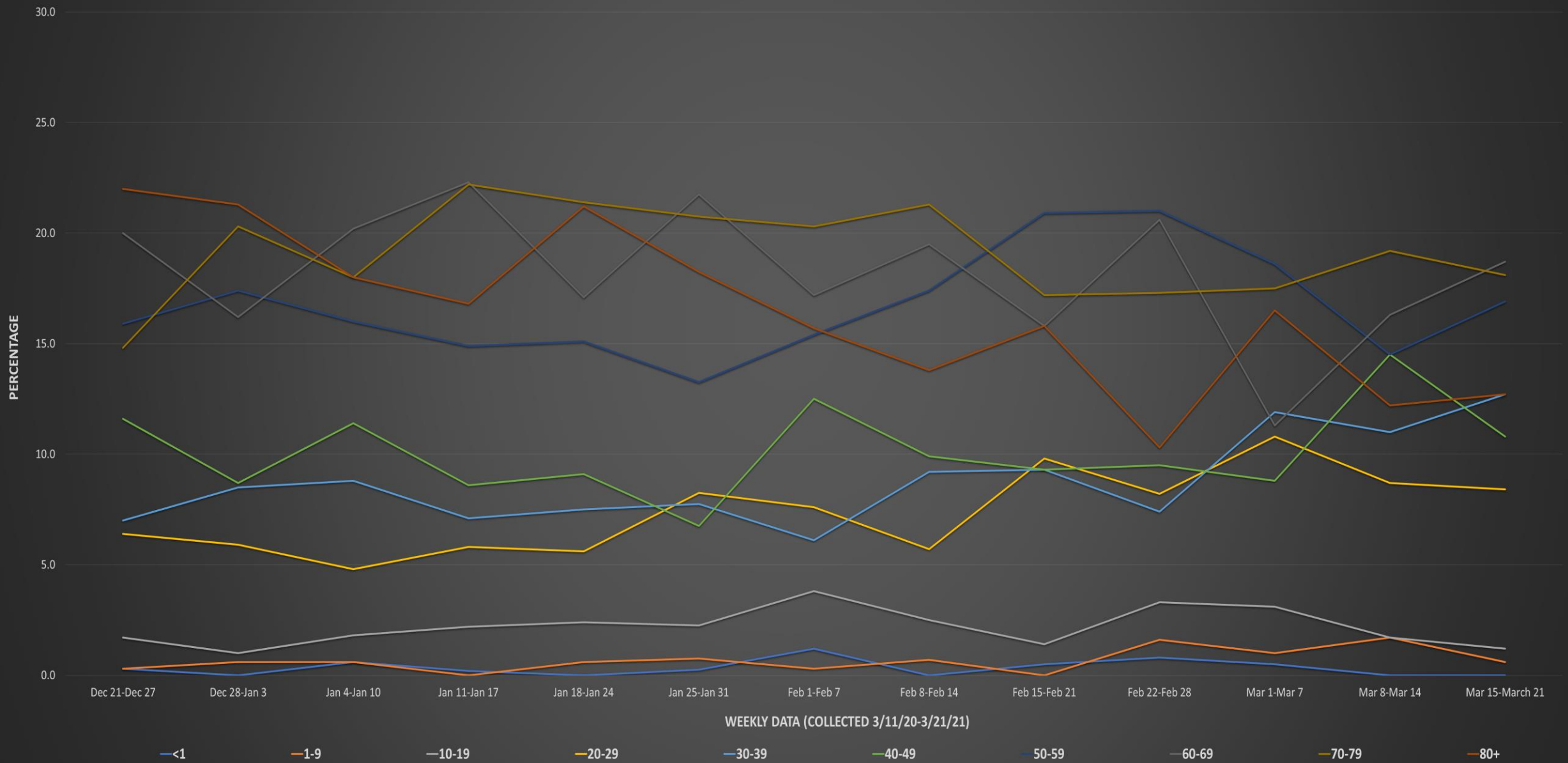

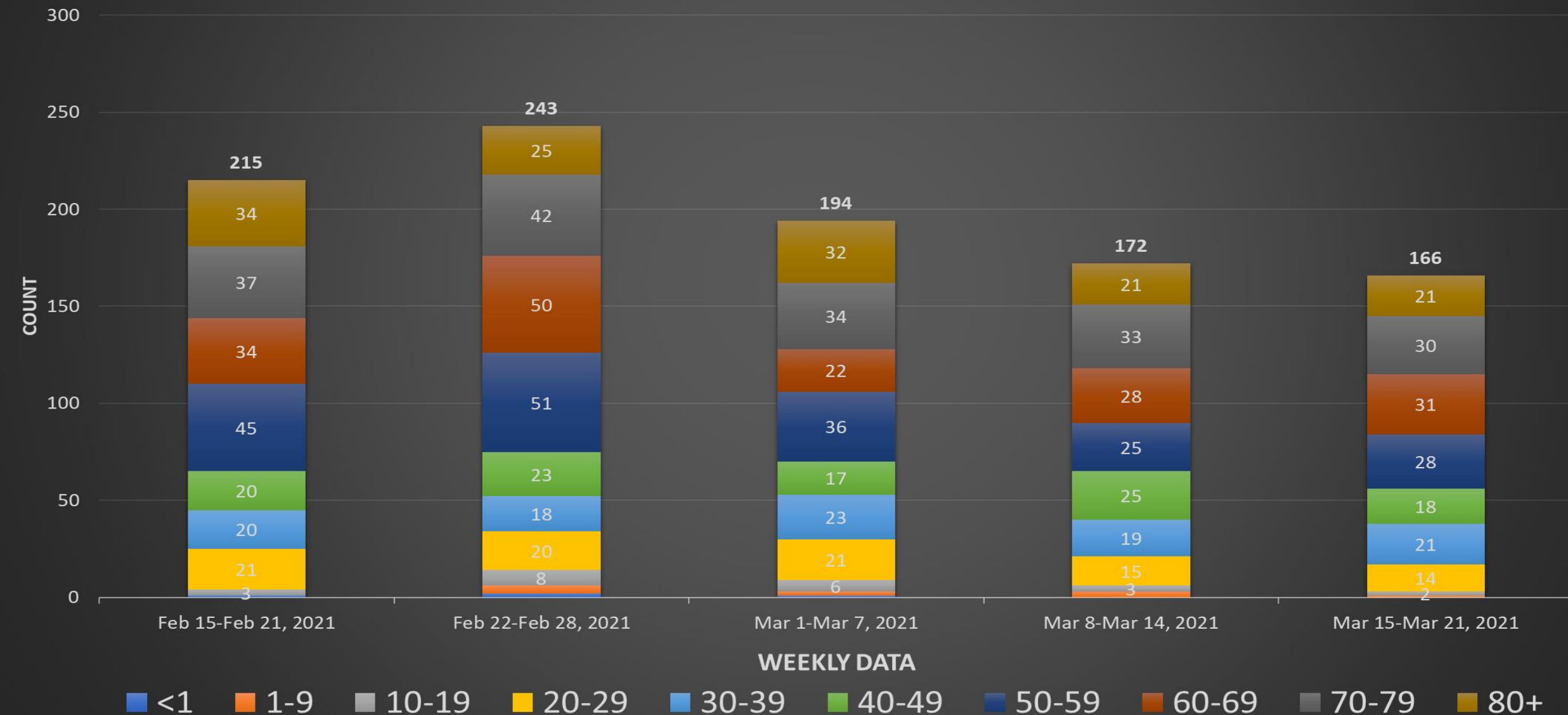

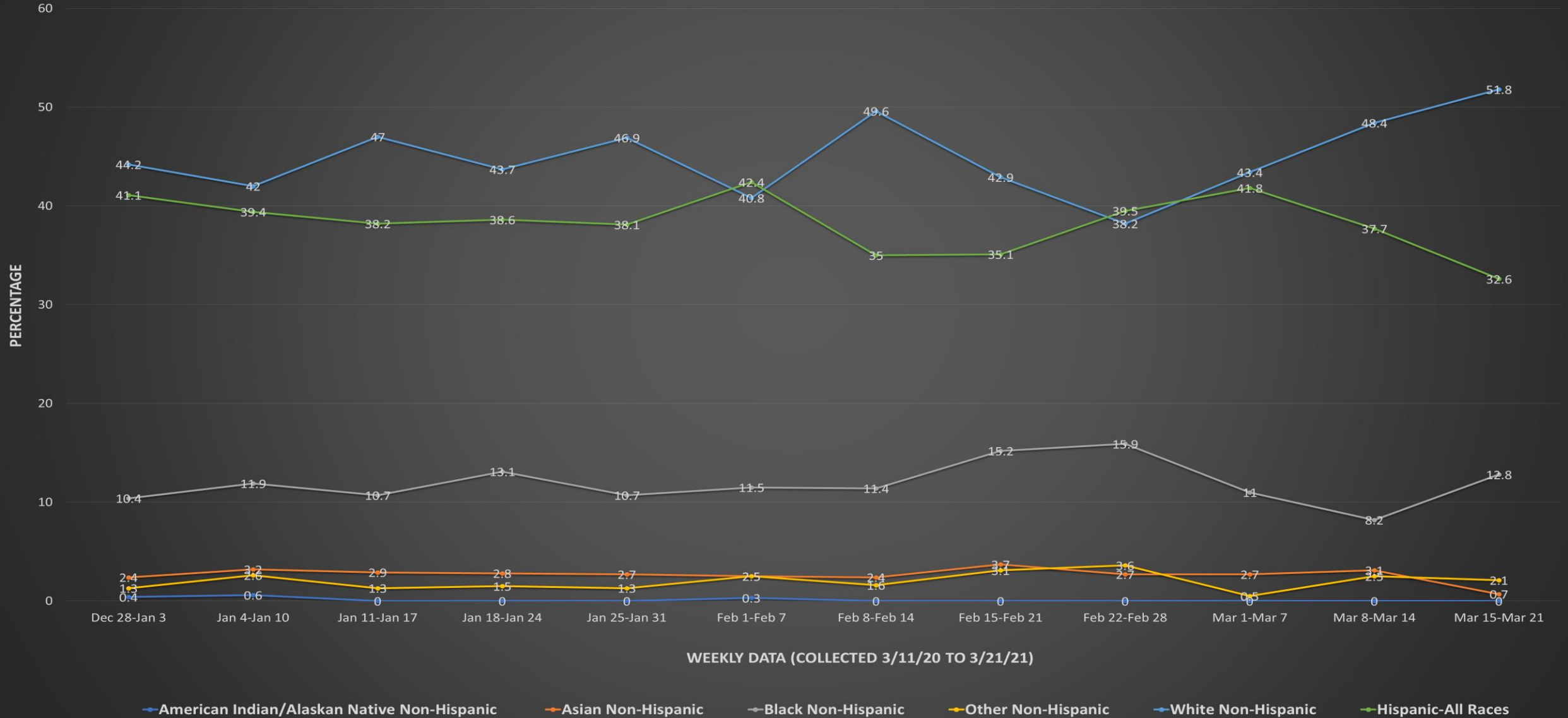
City of Austin - Travis County COVID-19 Hospitalization by Age Group (Austin MSA)



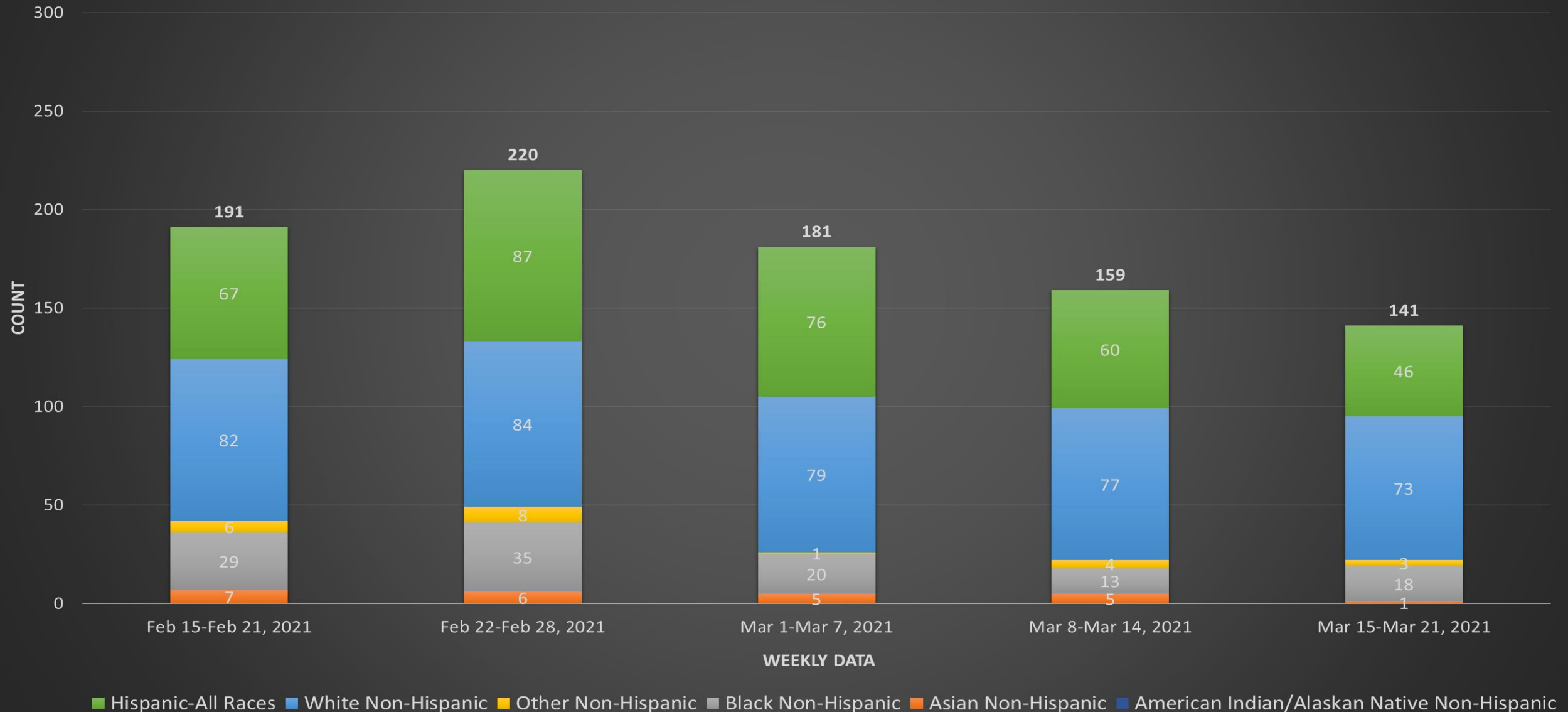
City of Austin - Travis County COVID-19 Count of Weekly Hospitalizations by Age Group (Austin MSA)

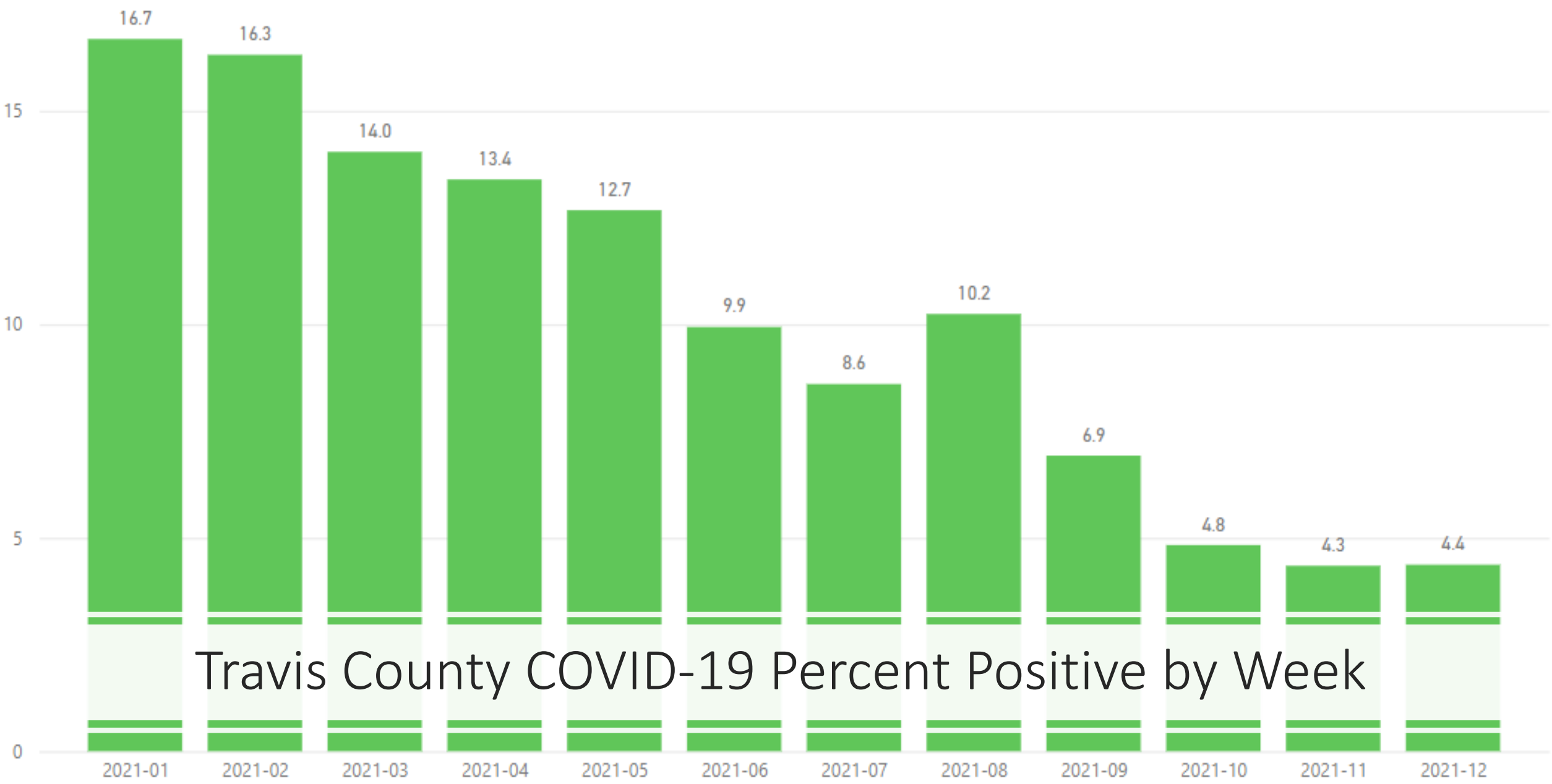


City of Austin - Travis County COVID-19 Hospitalization by Race & Ethnicity (Austin MSA)

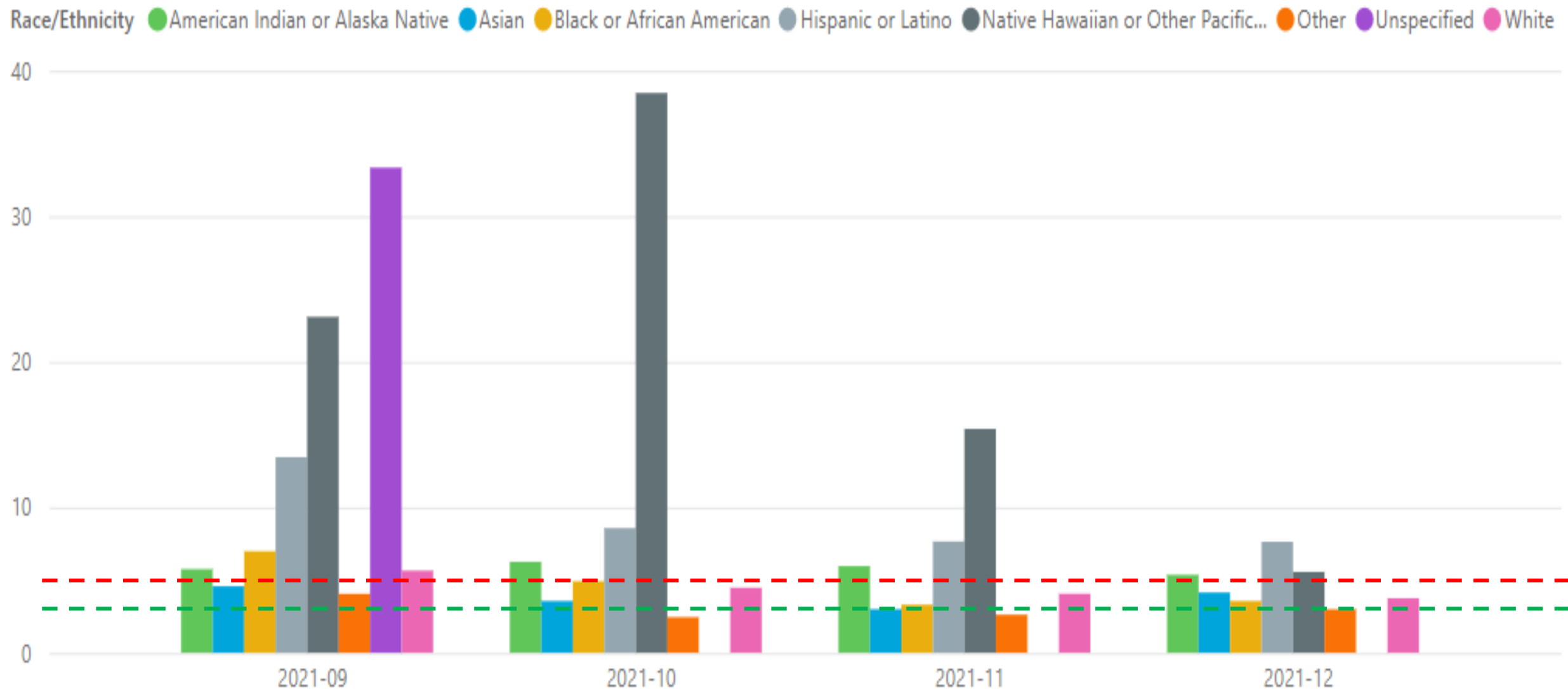


City of Austin - Travis County COVID-19 Count of Weekly Hospitalizations by Race/Ethnicity (Austin MSA)

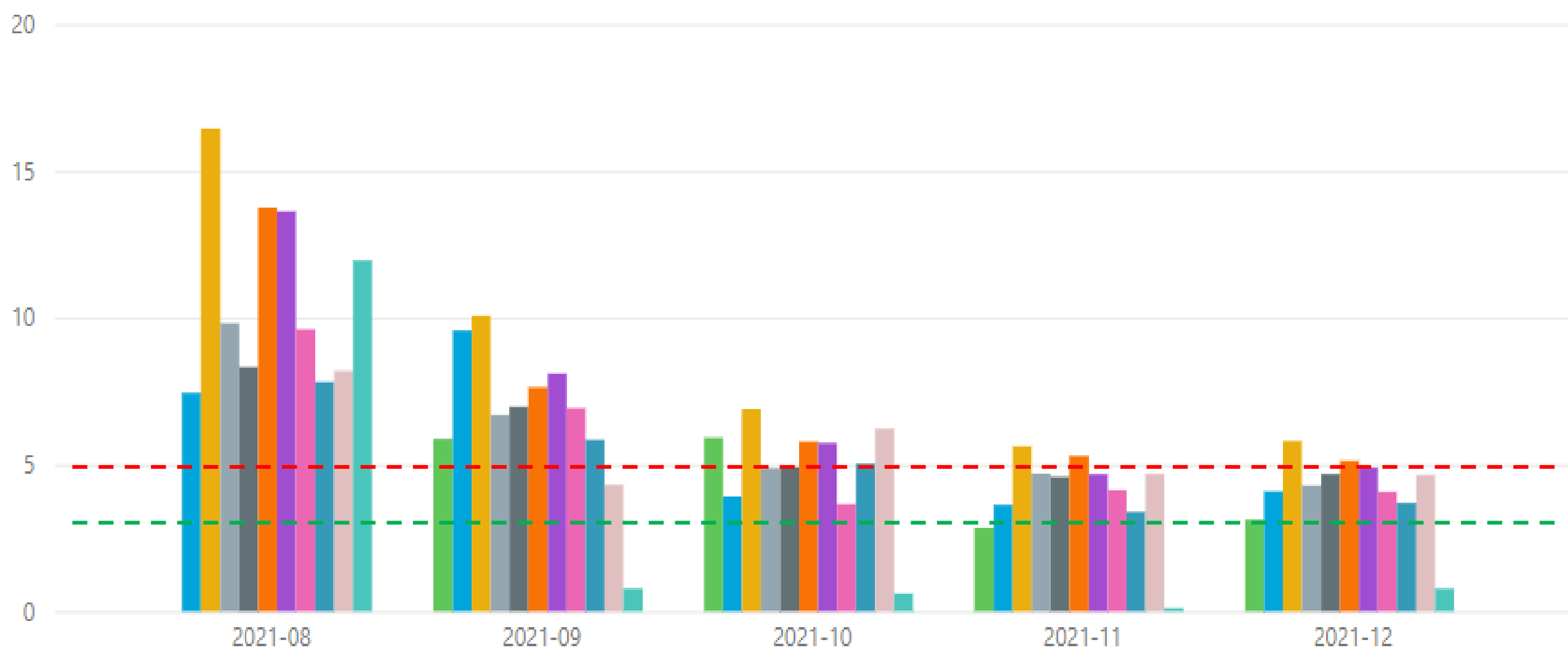




Travis County COVID-19 Percent Positive by Week

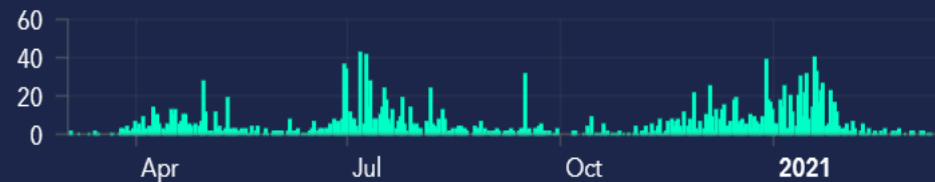

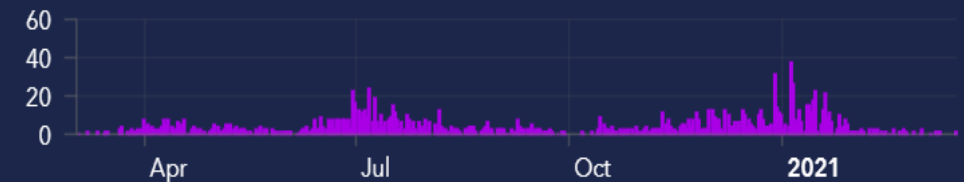

- 215 patients treated and discharged

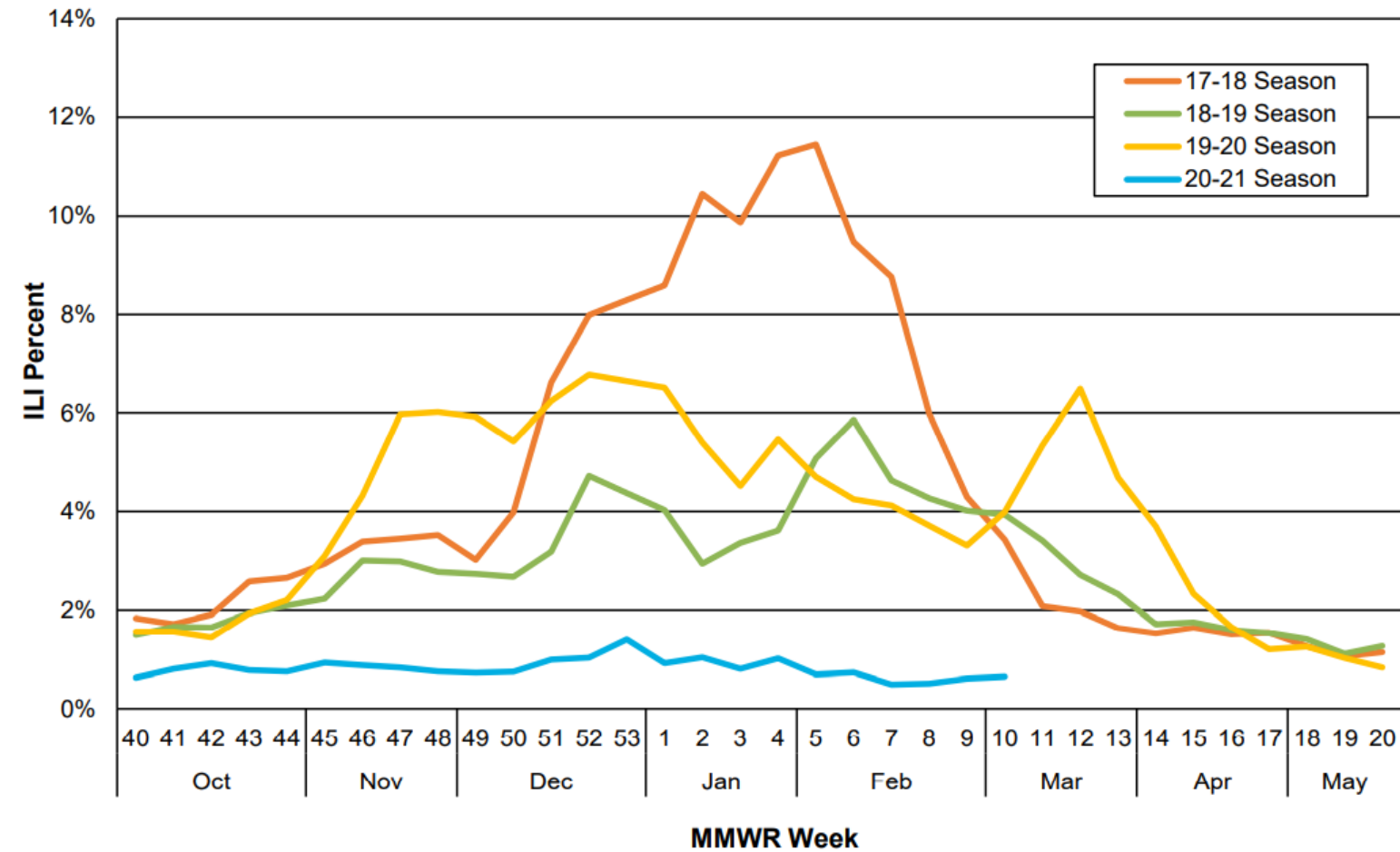

Stage 3 Recommendations

- **Wear a mask, social distance, and practice good hygiene**

- **Avoid gatherings with social groups greater than 10 people**

- **Avoid non-essential dining, shopping, and travel if you are high-risk**

- **Businesses voluntarily operate at a reduced capacity of 50-75%**

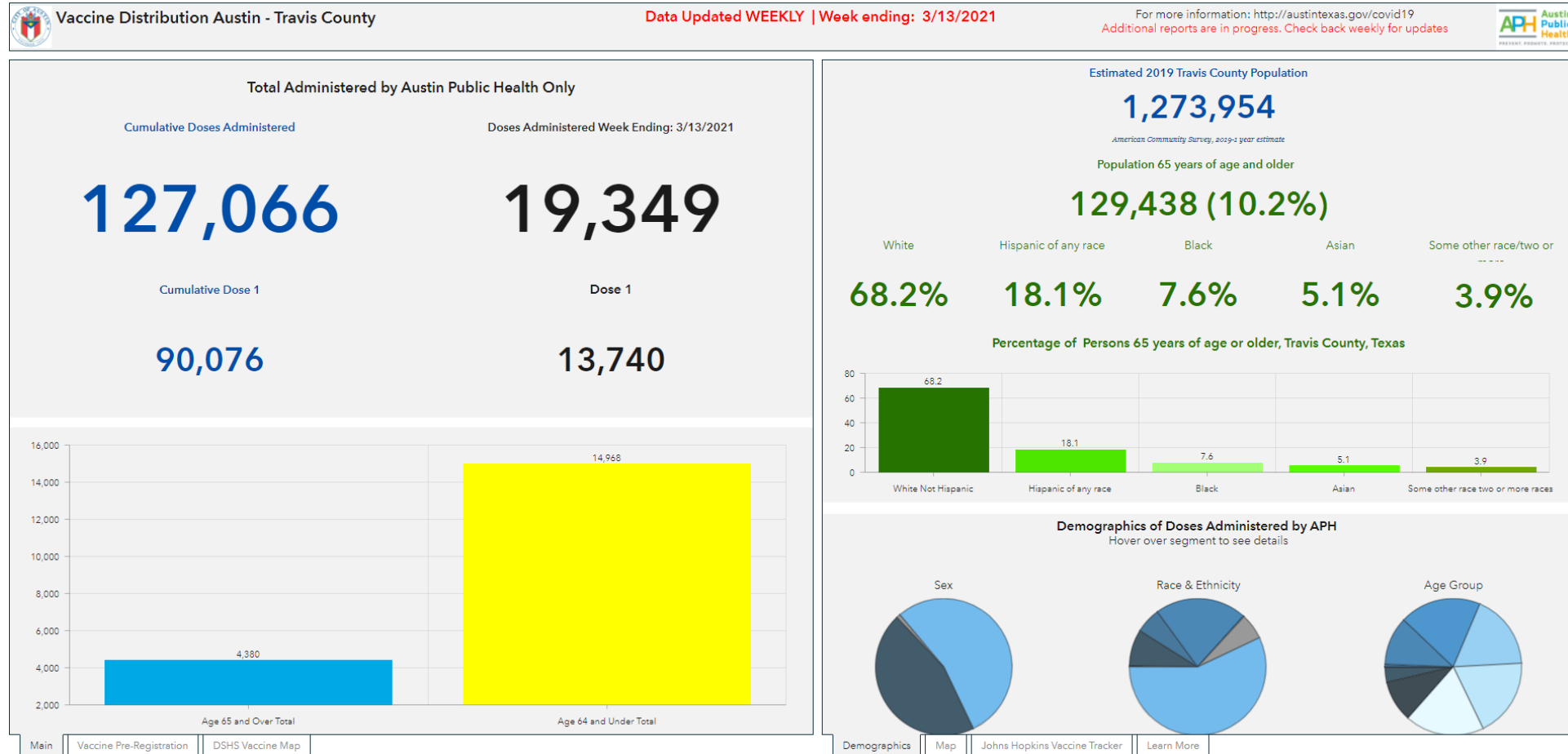

Vaccine Update

- **~148,844 TOTAL VACCINES**
(first/second doses)
administered as of 3/20
- Added 1C to registration system
- APH continues to receive Moderna vaccine
- 200 Johnson & Johnson sent to Shots for Tots Clinics last week
- Requested 12K J&J from state



AISD Performing Arts Center

Vaccine for Childcare, Education, and Senior Population Update

Childcare/School Staff

- ~10,100 school and childcare staff vaccinated as of 3/20

Senior Population

- Doses through APH (60 years and older as of 3/20):
 - First dose: 51,000
 - Second dose: 25,000

DSHS total

- ~76,822 Travis County residents 65 years or older have been vaccinated with at least one dose

Pilots: Toney Burger Center & Faith Based Program

Toney Burger Pilot

- ~1440 first doses 3/20
- 120 – 150 vaccines per hour
- Additional days of operation



Burger Activity Center 3/20/21

Faith Based Pilot Program

- ~1,760 first doses
- Partnership with Sacred Heart Church and Hispanic Contractors Association
- Coordinating with API and African American Churches for future outreach

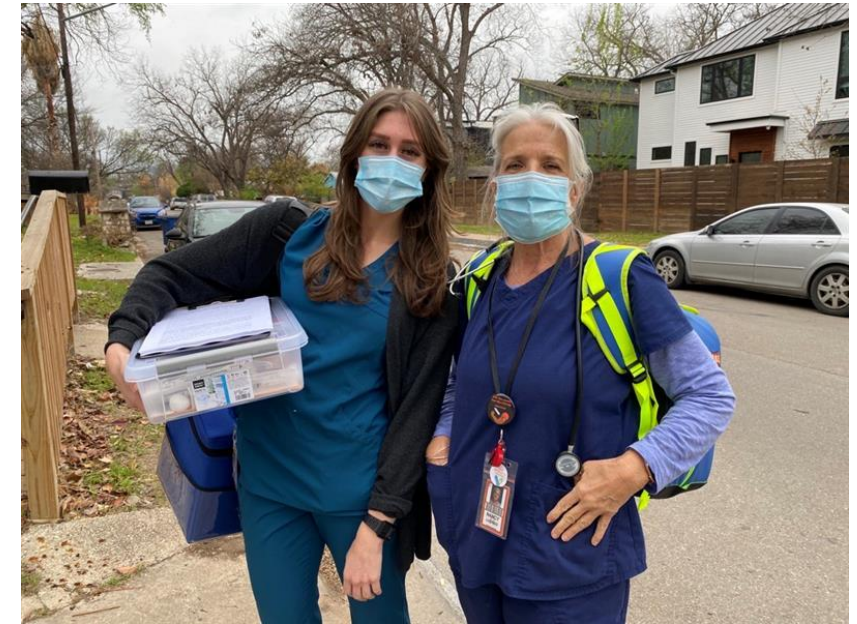

Meal on Wheels Partnership



- The partnership between the Mobile Vaccine Program and MOWCTX started on Monday, March 22, 2021.
- The first round will be in the Eastern Crescent area and this specific partnership will only cover clients in Travis County.
- Approximately 66 MOWCTX clients were vaccinated March 22, 2021, and the partnership will continue weekly through April.
- A spouse and/or caregiver will also receive a shot if they fall within the 1B or 1C category.

Scheduling System Update

Program Code Fixed

- ~16,500 first/second appointments scheduled since last Monday (3/15)
- 11,910 first dose online appointments scheduled last night (3/22)
 - Main release of appointments for **FIRST DOSES** go live ***Monday & Thursday evenings***



IT upgrades

Released 3/15:

- CDC Vaccine Card
- Email opt-out
- Account self-update
 - Contact information
 - Emergency contacts



In development:

- User friendly design
- Account self-update
 - Waiting list opt-out (vaccinated elsewhere)

Looking Ahead

- Possible additional state allocations to all providers (~350 locations) in April
- Current operations are scalable
 - ~37,000 capacity a week
- APH reverts from hub to safety net provider **once more vaccine is available to private providers**
