To speak remotely at the **April 23, 2021** Zero Waste Advisory Commission Construction and Demolition Ordinance Reform Committee Meeting, members of the public must:

- Speakers must call in at least 15 minutes prior to meeting start time in order to speak, late callers will not be accepted and will not be able to speak.
- Speakers will be placed in a queue until their time to speak.
