1	RESOLUTION NO.
2	WHEREAS, the City is committed to the safety, health, and welfare of all
3	of its residents; and
4	WHEREAS, ensuring the safety of Austin residents, public safety officers,
5	and visitors is a top City priority; and
6	WHEREAS, the United States Centers for Disease Control and Prevention
7	reports that gun violence in the United States is at epidemic levels, claiming over
8	30,000 lives annually; and
9	WHEREAS, the epidemic of gun violence includes horrific events such as
.0	mass shootings, intimate partner and domestic violence, suicides, homicides,
.1	accidental firearm discharge, and
.2	WHEREAS, in April 2021, Austin Police Department Interim Chief Joe
.3	Chacon announced a new initiative to combat local gun violence, and
.4	WHEREAS, the Austin Police Department has reported an increase in gun
.5	violence and cited that many of the firearms used in these crimes were obtained
.6	illegally, and
.7	WHEREAS, according to the National Law Enforcement Officers
.8	Memorial Fund, in 2011, firearms were the number one cause of death for police
.9	officers killed in the line of duty; and
.0	WHEREAS, during the 116th and the 117th Congress, House Resolution 8
1	(H.R. 8) was approved on a bipartisan basis in the United States House of
2	Representatives to require background checks for all commercial gun sales; and

WHEREAS, approval of H.R. 8, marked the first time major gun safety legislation has passed the United States House of Representatives in more than twenty years; and

WHEREAS, since H.R. 8 was passed by the United States House of Representatives, in the 116th and the 117th Congress, the United States Senate has not debated or voted on this important legislation; and

WHEREAS, in addition to the daily scourge of gun violence, Texas has suffered numerous mass acts of gun violence including on August 3, 2019 in El Paso, Texas where 20 individuals are reported to have been killed by a shooter who, according to initial reports, uploaded an online manifesto describing a so-called "Hispanic invasion of Texas, and referencing inspiration from the attack on mosques in Christchurch, New Zealand that left 51 dead; and

WHEREAS, after the May 18, 2018 shooting at Santa Fe High School, in Santa Fe, Texas, where 10 people were killed and 13 injured, Texas Governor Greg Abbott met with superintendents, administrators, law enforcement officials, as well as survivors of gun violence, to discuss policies that could increase the safety of schools and communities while preserving Second Amendment rights; and

WHEREAS, on May 30, 2018 Texas Governor Greg Abbott released a School and Firearm Safety Action Plan, which included a recommendation encouraging the Texas Senate and House leaders to consider the merits of adopting a red flag law or "extreme risk protective orders" allowing law enforcement, a family member, a school employee, or a district attorney to file a petition seeking the removal of firearms from a potentially dangerous person only after legal due process is provided; and

48	WHEREAS, Texas Governor Greg Abbott's School and Firearm Safety
49	Action Plan described the so called "red flag laws" as a proposal which could have
50	been used to prevent the shootings at Sutherland Springs and at Marjory Stoneman
51	Douglas High School in Parkland, Florida; and
52	WHEREAS, on average over 3,350 gun-related deaths occur in Texas each
53	year; and
54	WHEREAS, in October of 2019, Everytown for Gun Safety, the country's
55	largest gun violence prevention organization, released the report, "Guns and
56	Intimate Partner Violence: America's Uniquely Lethal Intimate Partner Violence
57	Problem," and found that in at least 54 percent of mass shootings the perpetrator
58	shot a current or former intimate partner or family member; and
59	WHEREAS, the report also found that between 2009 and 2018, 80 percent
60	of child victims of mass shootings died in incidents connected to domestic or
61	family violence; and
62	WHEREAS, according to the Federal Bureau of Investigation's 2019 report,
63	"Uniform Crime Reporting Program: Supplementary Homicide Reports (SHR)
64	2014-2018," every month, an average of 53 women are shot and killed by an
65	intimate partner and nearly 1 million women alive today have reported being shot
66	or shot at by intimate partners; and
67	WHEREAS, during the 86th Legislative Session and the 87th Legislative
68	Session the Texas House and Senate did not approve important gun safety
69	legislation consistent with Texas Governor Greg Abbott's 2018 School and
70	Firearm Safety Action Plan; and

71 WHEREAS, local organizations, including Texas Gun Sense and local 72 chapters of Moms Demand Action for Gun Sense in America, have advocated at the Texas Legislature for sensible gun safety legislation; and 73 WHEREAS, the 86th Texas Legislature adjourned without taking sufficient 74 action to reduce the risk of gun violence in our schools and communities; and 75 WHEREAS, during the 87th Texas Legislature, the Texas House approved 76 HB1927 which would eliminate requirement for Texans to get a license to carry a 77 firearm if they are not already prohibited by state or federal law from possessing a 78 firearm; and 79 WHEREAS, City Council has taken extensive action to address the 80 epidemic of gun violence including Resolution No. 20130228-035 signifying City 81 Council's intent to endorse efforts to develop a comprehensive approach to 82 reducing gun crime as well as Resolution Nos. 20161215-064, 20171207-054, 83 84

20180510-047, 20190808-149, and 20190822-069; and

WHEREAS, Austin has continued to experience the daily toll of gun violence, including events such as the January 27th, 2021 fatal shooting of a local pediatrician, the non-fatal shooting involving a law enforcement officer on April 9th, 2021, and the fatal shooting of three Austinites on April 18th, 2021, and NOW, THEREFORE,
