South Central Waterfront Advisory Board Special Called Meeting to be held April 28, 2021 with Social Distancing Modifications

To speak remotely at the April 28, 2021 South Central Waterfront Advisory Board Meeting, members of the public must:

The following information is required: speaker name, item number(s) they wish to speak on, whether they are for/against/neutral, email address and telephone number (must be the same number that will be used to call into the meeting).
- Once a request to speak has been made to the board liaison, the information to call on the day of the scheduled meeting will be provided either by email or phone call.
- Speakers must call in at least 15 minutes prior to meeting start time in order to speak, late callers will not be accepted and will not be able to speak.
- Speakers will be placed in a queue until their time to speak.
