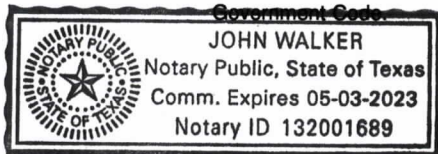

I, SPENCER CRONK, City Manager of the City of Austin, swear or affirm on penalty of perjury that the following is true and correct:


Based on my spouse's recent employment with the following identified nonprofit entity, I have a substantial interest in the non-profit entity.

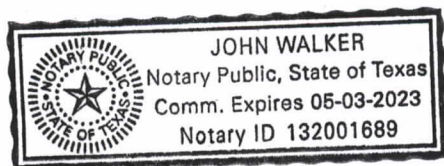


