## CALL TO ORDER - April 14, 2020, 4:00 p.m.

## 1. APPROVAL OF MINUTES

a. Approval of minutes from the March 4, 2020 Impact Fee Advisory Committee meeting. *Committee Member (CM) Tehrany moved approval, CM Parisher seconded and the minutes were approved 4-0.*.

## 2. OLD BUSINESS

a. Staff presentation of policy options for the street impact fee.

Jeff Whitacre (consultant with Kimley-Horn managing the street impact fee study) presented two approaches to the collection rates for the street impact fee based on the discussion at the previous meeting. Chair Bailey and CM Soeur joined the meeting during the presentation. The presentation was paused for committee members to ask questions. A discussion on the approach to the policy ensued so the chair paused the discussion to combine Items 2a and 2b to allow for the discussion during the presentation. Jake Gutekunst (also with Kimley-Horn) continued presenting on different

fee schedule options. The committee members discussed whether a fee cap for certain service areas was appropriate. The committee discussion was that a flat percentage of the maximum allowable fee was preferred over a flat rate across the city. The committee agreed on 50% of the maximum for non-residential developments and 35% of the maximum for residential developments for the collection rate.

A community member, Cody Carr, signed up to speak on Item 2b and was called on to speak at 5:31.

The discussion continued regarding the effective date of the ordinance; there was agreement on a one-year grace period for all properties. There was also a discussion about fee reductions; the committee agreed on the internal capture and transportation demand management reductions and did not specify a reduction for affordable housing. CM Turrieta made a motion to allow the chair to review and finalize the letter containing the committee's comments for City Council after the committee liaison received any additional comments from members. CM Tehrany seconded the motion and it was approved 6-0.

b. Discussion and approval of committee comments on the street impact fee policy proposal and draft ordinance.

See above. Items 2a and 2b were combined for discussion purposes.

c. Discussion and possible action on future Impact Fee Advisory Committee meeting dates for 2020.

The committee discussed that the next IFAC meeting date would be late summer pending the availability of the next semi-annual water/wastewater impact fee report.
