 - Commissioner Norton provided an update. Commissioner Clinton moved that the Animal Advisory Commission approve the group working with the Parks and Recreation Department's (PARD) Board group on the issue of off-leash dogs. Commissioner Nazor seconded the motion which passed unanimously, 12 to 0, with all commissioners voting in favor: Commissioners Mitchell, Nazor, Jarl, Neuhaus, Flores, Dr. Brandes, Frenden, Norton, Clinton, Nemer, Smagula and Rodriguez Pacheco voting approval. District 6 position is vacant.

4. NEW BUSINESS

a. Election of Officers

Chair: Commissioner Nemer nominated Craig Nazor for Chair; Commissioner Dr. Jon Brandes nominated Ryan Clinton for Chair. The vote was 7 to 3 for Commissioner Nazor with Commissioners Nazor, Flores, Nemer, Norton, Jarl, Smagula, Rodriguez Pacheco voting for him. Commissioners Dr. Brandes, Neuhaus and Frenden voted for Commissioner Clinton. Commissioners Mitchell and Clinton abstained.

Vice Chair: Commissioner Norton nominated herself with a second from Commissioner Nazor; Commissioner Jarl nominated Commissioner Clinton who was approved on a vote of 7 to 5. Commissioners Norton, Nazor, Flores, Smagula and Rodriguez Pacheco voted for Commissioner Norton; Commissioners Clinton, Dr. Brandes, Neuhaus, Jarl, Nemer, Frenden and Mitchell voted for Commissioner Clinton.

Parliamentarian: Commissioner Nazor nominated Commissioner Nemer to continue as Parliamentarian, and the vote was unanimous, 12 to 0, for Commissioner Nemer to serve as Parliamentarian. Commissioners Mitchell, Nazor, Jarl, Neuhaus, Flores, Dr. Brandes, Frenden, Norton, Clinton, Nemer, Smagula and Rodriguez Pacheco voted approval. District 6 position is vacant.
