In the may 1st election the returns of the elections show that there were 124,334 votes for and 29,110 votes against proposition a. 90,498 votes for and 66,360 votes against proposition B. 96,993 votes for and 57,307 votes against proposition C.

102,174 votes for and 51,536 votes against proposition D. 87,604 votes for and 63,560 votes against proposition E. 21,805 votes for and 449,002 votes against proposition F. It 85,410 votes against proposition G. 65,553 votes for and 87,734 votes against proposition H.
