SUBJECT: Clarification Memo Austin Public Health Items #17 – Caritas of Austin and

#18 – Austin/Travis County Mental Health & Mental Retardation Center

The City Council agenda for May 20, 2021, includes *agenda item #17*, a recommendation seeking Mayor and Council's approval to negotiate and execute an agreement with Caritas of Austin to provide permanent supportive housing to disabled individuals who have experienced chronic homelessness, in an amount not to exceed \$2,992,800 for the term July 1, 2021 to September 30, 2022, with three 12-month extension options each in an amount not to exceed \$2,671,680, for a total agreement amount not to exceed \$11,007,840.

The first paragraph in the Additional Backup Information currently reads as follows:

This action will authorize the negotiation and execution of an agreement with Caritas of Austin to provide permanent supportive housing (PSH) at **13311 Burnet Rd Austin**, **TX**, to disabled individuals who have experienced chronic homelessness.

Staff would like to correct and replace that language with the following:

This action will authorize the negotiation and execution of an agreement with Caritas of Austin to provide permanent supportive housing (PSH) at 10811 Pecan Park Blvd. Bldg 2, Austin, TX, to disabled individuals who have experienced chronic homelessness.

The, City Council agenda for May 20, 2021 includes *agenda item #18*, a recommendation seeking Mayor and Council's approval to negotiate and execute an agreement with Austin/Travis County Mental Health & Mental Retardation Center (d/b/a Integral Care) to provide permanent supportive housing to disabled individuals who have experienced chronic homelessness, in an amount not to exceed \$1,558,200 for the term July 1, 2021 to September 30, 2022, with three 12-month extension options each in an amount not to exceed \$1,199,220, for a total agreement amount not to exceed \$5,155,860.
