Recommend approval to award and execute a construction contract with **Underground Water Solutions Co., (MBE)** for the West 9th and 12th Streets Water and Wastewater Renewal project in the amount of \$1,886,023.24 plus a \$188,602.32, for a total contract amount not to exceed \$2,074,625.56.
