### **Zero Waste Advisory Commission to be held Wednesday, July 14<sup>th</sup>, 2021 with Social Distancing Modifications**

Public comment will be allowed via telephone; no in-person input will be allowed. **All speakers must register in advance (Tuesday, July 13<sup>th</sup>, 2021 by noon).** All public comments will occur at the beginning of the meeting.

To speak remotely at the **Zero Waste Advisory Commission** Meeting, members of the public must:

- Call or email the board liaison at (512) 974-2435 [Dwight.Scales@austintexas.gov](mailto:Dwight.Scales@austintexas.gov) no later than noon, (the day before the meeting). The following information is required: speaker name, item number(s) they wish to speak on, whether they are for/against/neutral, email address, and telephone number (must be the same number that will be used to call into the meeting).
- Once a request to speak has been made to the board liaison, the information to call on the day of the scheduled meeting will be provided either by email or phone call.
- Speakers must call in at least 15 minutes prior to meeting start time in order to speak, late callers will not be accepted and will not be able to speak.
- Speakers will be placed in a queue until their time to speak.
